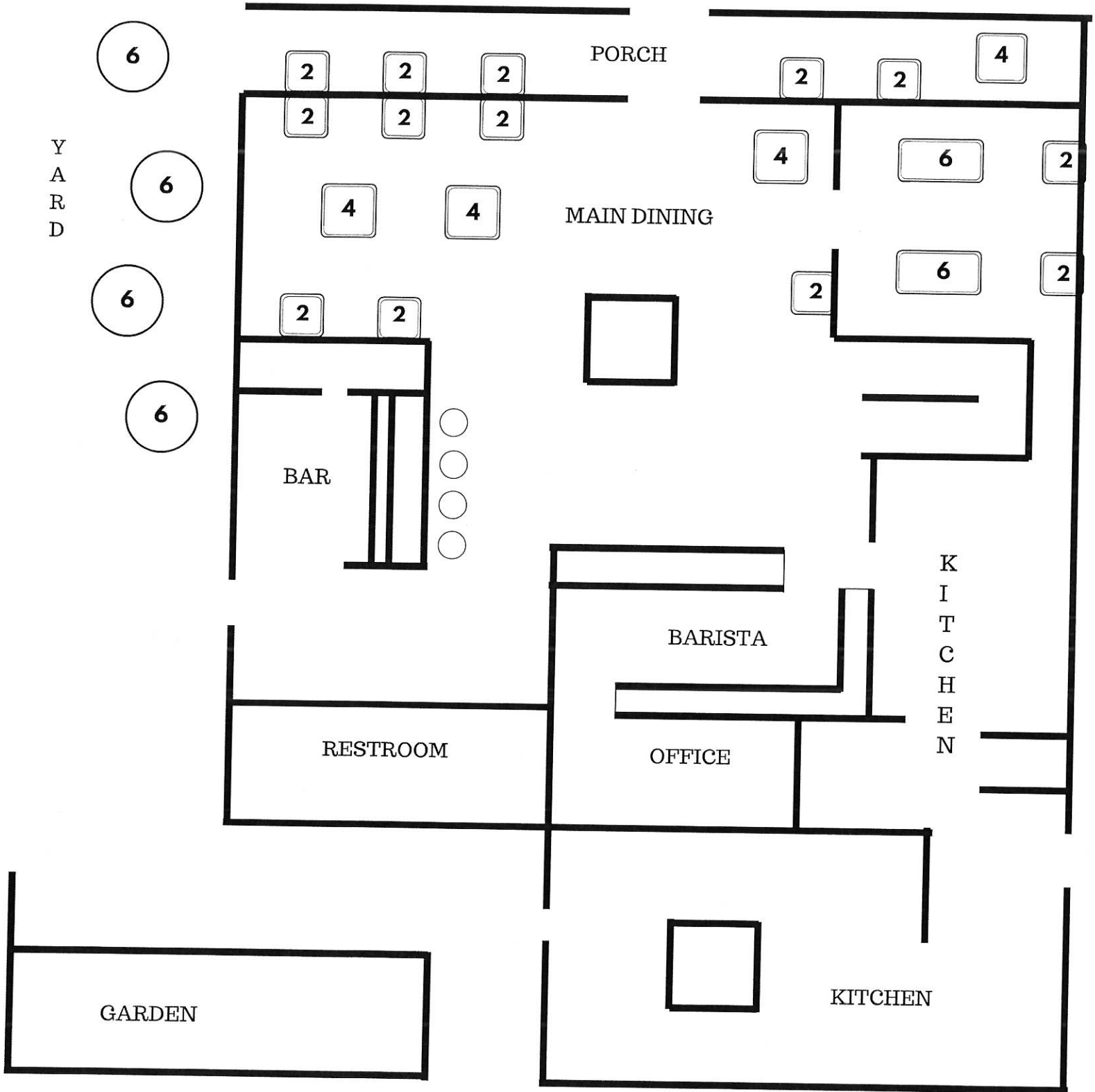

# MAIN FLOOR PLAN



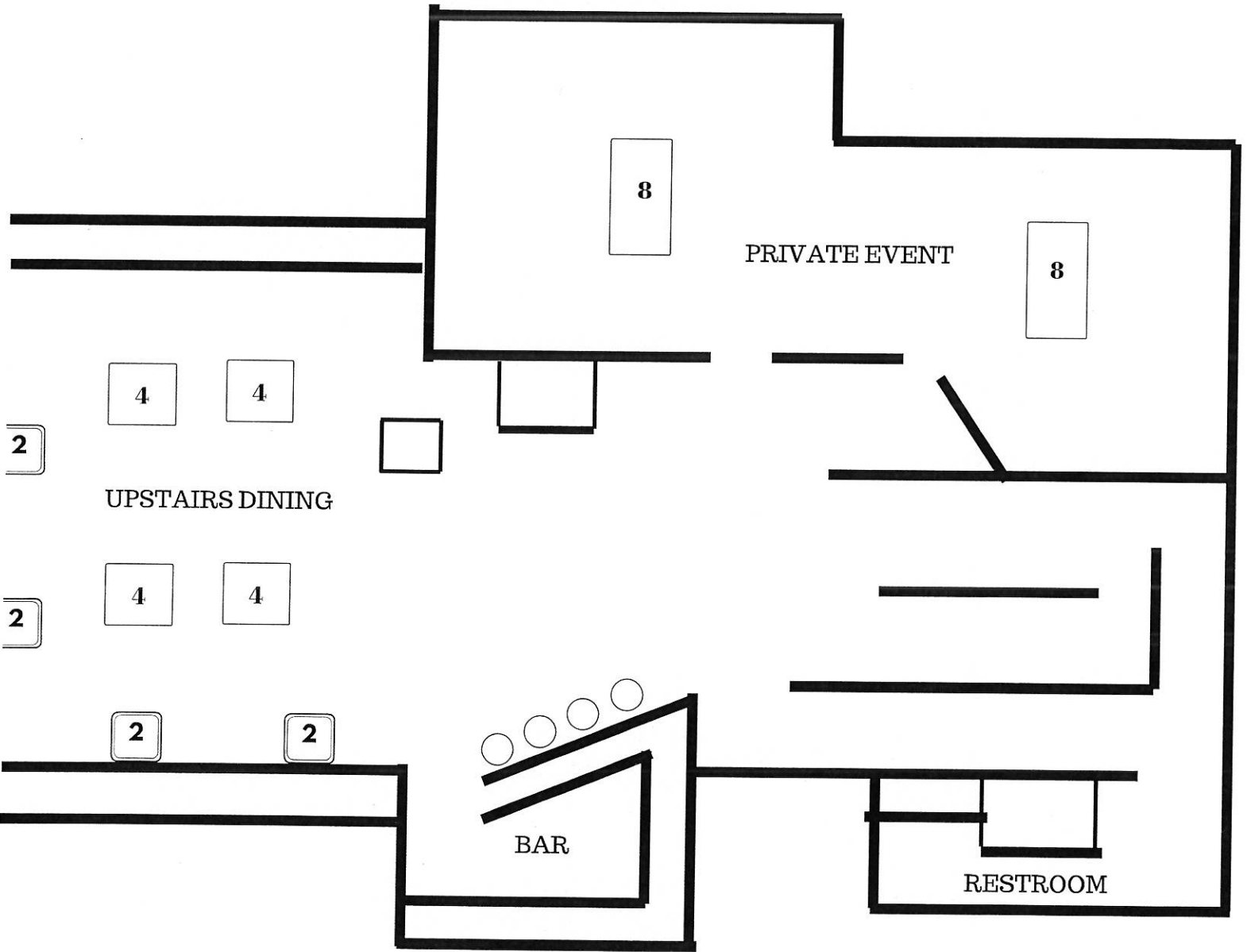

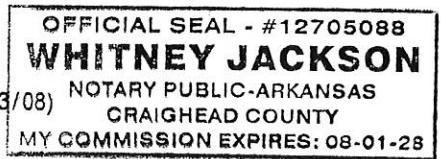

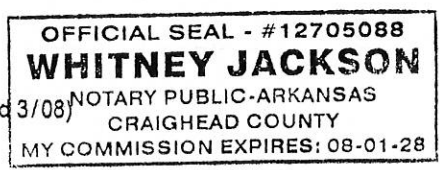
