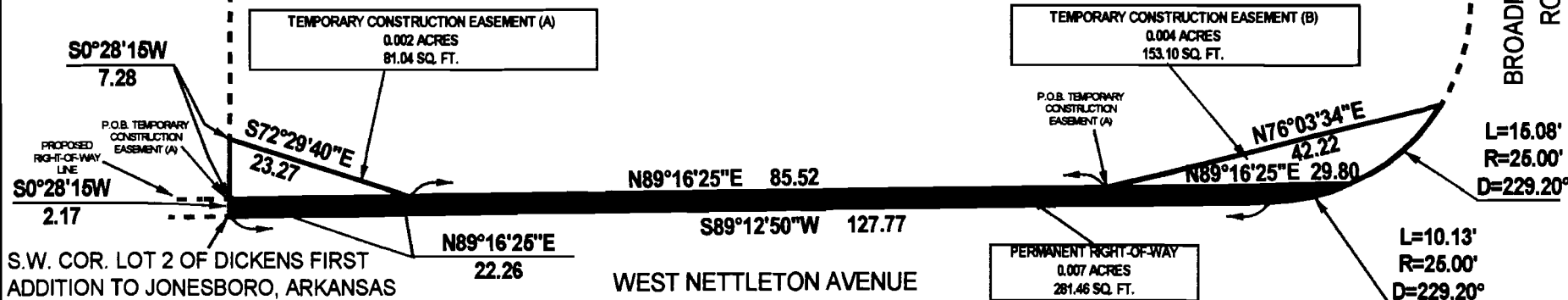



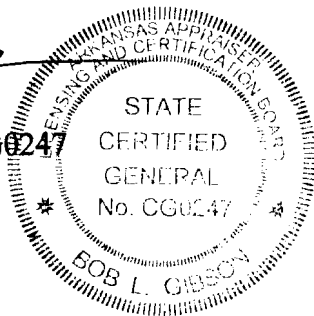
Dear Mr. Scott:

I have appraised the above property as of May 14, 2002, and find the market value to be \$33,264. In accordance with your instructions, I have reduced the lot size by the "amount ofaking" for the purpose of widening Nettleton Avenue. The remaining value is \$32,814 or a difference of \$450 which is the just compensation due the owner. In addition, a temporary easement in the amount of 234.14 sq ft is being used. A fee of \$150 is paid for this inconvenience bringing total compensation to \$600.
