Regarding: Meeting at LOPFI-PRB regarding Retired Firefighters' Pension Fund

Dear Counselor Oldham:

This letter is in response to your correspondence dated October 29, 2010. Today, Jim Eagan, Ben Barylske, and myself, met with David Clark, Executive Director of LOPFI concerning the above pension plan. I wanted to share with you several items discussed at the meeting, as follows:

- 1) In 1997, the City of Jonesboro transferred \$7.7 million to LOPFI which represented the total assets of the plan. However, at that time, the plan also had an unfunded liability of \$2.2 million.
- 2) When the funds were transferred, the plan benefits were increased from 50% of base pay, to 75% of base pay, thereby increasing the future obligations of the fund significantly. We learned many plans still maintain benefits at 50% of base pay.
- 3) Mr. Clark informed us that the millage levy collected is allocated for both the above fund and for active members covered by LOPFI.
- 4) LOPFI provided us with a copy of the allocation of contributions for 1997 through 2009. This information is attached for your benefit.
- 5) One major item we reviewed was the current level of unfunded liability which is \$11.1 million, which must be paid in full by 2037.
- 6) David Clark advised us that due to regulatory changes in 2003, no benefit increases can be funded with state insurance premium turnback, and must be paid with general fund revenues.
