ORDER OF ANNEXATION

On this _____ day of October, 1983, comes on for hearing before the Court, the Petition for Annexation of certain lands to the City of Jonesboro, Arkansas, filed in this Court on _____, 1983, the Petitioner appearing by and through his attorney Jim Lyons. This cause is heard upon the Petition duly verified, the exhibits thereto, and the notice of filing of said Petition and of the date, time and place of hearing thereof, and a proof of publication of such notices required by law, and the evidence introduced by the witnesses, argument of counsel and all other things and matters coming before the Court, from all of which the Court finds:

1. That said Petition is signed by the sole owners of the land hereinafter described; that the notice of filing of said Petition and date, time and place of hearing upon said Petition has been duly given and published as required by law; that all things required by law to be done have been duly and properly done; that the allegations of the Petitioner are sustained by proof; that the requirements for signature have been duly complied with; that the limits of the territory and lands to be annexed have been accurately described; that an accurate plat thereof has been duly made and filed with this Court, and the prayer of the Petitioner thereof has been duly made and filed with this Court; and the prayer of the Petitioner is right and proper; that the lands hereinafter described should be annexed to the City of Jonesboro, Arkansas.


It is, therefore, by the Court, CONSIDERED, ORDERED and ADJUDGED that the Petition herein be and is hereby granted and all the lands and territories hereinafter described be and are hereby annexed to the City of Jonesboro, Arkansas,

said lands and territories so annexed to the City of Jonesboro, Arkansas, being more particularly described as follows, to wit:

Part of the West 273 feet of the North 301.9 feet of the Northwest Quarter of the Southwest Quarter of Section 27, Township 14 North, Range 4 East, subject to right of way of 30 feet along the West side of the tract for Richardson Drive and right of way of 30 feet along the North side thereof for Race Street, containing 1.89 acres less and except 0.53 acres in a tract lying in the Northwest Corner more particularly described as follows: Beginning at the Northwest Corner of the Southwest Quarter of Section 27, Township 14 North, Range 4 East; thence South $89^{\circ} 46'$ East along the Half Section line 135.4 feet; thence South $1^{\circ} 05'$ West 172.0 feet; thence North $89^{\circ} 46'$ West 135.4 feet; thence North $1^{\circ} 05'$ East 172.0 feet to the point of beginning proper containing 0.53 acres, leaving a net area of 36 acres.

Be it further ordered, that said lands and territories shall be deemed and taken to be a part of the limits of the City of Jonesboro, Arkansas, and the inhabitants residing therein shall have and enjoy all the rights and privileges of the inhabitants within the original limits of the City of Jonesboro, Arkansas, upon said lands and territories being accepted by the resolution or ordinance of the City Council of the City of Jonesboro, Arkansas.
