FROM THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF SECTION 21, TOWNSHIP 14 NORTH, RANGE 4 EAST, THENCE N00°42'38"E 90.19 FEET ALONG THE WEST LINE OF SAID NORTHWEST QUARTER TO A POINT, THENCE N89°42'36"E 40.90 FEET TO A POINT ON THE EASTERLY RIHT OF WAY OF CARAWAY ROAD, THENCE N00°37'46"E 166.57 FEET ALONG SAID RIGHT OF WAY TO THE NORTHWEST CORNER OF LOT 1 OF BODDIE-NOELL SUBDIVISION, THENCE S89°08'10"E 175.37 FEET ALONG THE NORTH LINE OF SAID LOT 1 TO THE POINT OF BEGINNING, CONTINUE THENCE S89°08'10"E 10.00 FEET TO THE NORTHEAST CORNER OF SAID LOT 1, THENCE S00°50'09"W 195.88 FEET ALONG THE EAST LINE OF SAID LOT 1 TO A POINT ON THE NORTHERLY RIGHT OF WAY OF NETTLETON AVENUE, THENCE N86°19'31"W 9.99 FEET ALONG SAID RIGHT OF WAY TO A POINT, THENCE N00°50'09"E 192.47 FEET TO THE POINT OF BEGINNING, CONTAINING SOME 1,956 SQ. 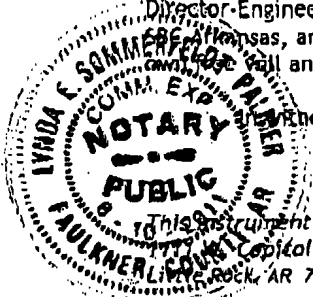
