Councilman Hargis inquired if the City is receiving less funding from the federal subsidiary. JETS Director Steve Ewart answered the funding issues have nothing to do with the money received from the federal subsidiary, but with less funding being received from advertising and state income. He added nothing has changed with the federal grants.

Mr. Ewart explained JETS has no problem accessing the funds that are available in the federal grant, but the repayment for the drawdowns is due to an audit finding in

either late 2007 or early 2008.

Councilman Hargis asked what percentage of the federal subsidiary equals to the cost of JETS. Mr. Ewart answered the federal percentage equals to 58% and the local percentage is 42%.
