Mayor Formon explained the bid specs were for the current signal's decibels. He further explained Federal Signal bid the 130 decibels, but Public Safety bid only 128 decibels. Mr. Jim Tucker from Federal Signal Corporation discussed their proposal for the City. Mayor Formon questioned whether the City would be losing about 1,600 feet of coverage by going with 128 decibels instead of 130. Mr. Tucker stated that is approximately right. He added mapping will show you what coverage each siren will have. He stated the 128's will probably do better than most of the old sirens that are out there at this point. Councilman Perrin questioned the last time the City bought anything from Federal. Mr. Tucker answered he is not sure, but he thinks it's been four or five years. He noted all the old 2001 sirens can be upgraded to today's modern technology. Councilman Perrin clarified all of the old sirens can be upgraded as another alternative. Mr. Tucker answered yes.

Councilman McCall questioned the problem with MoArk. Mayor Formon stated he was not there for the bid opening so he doesn't know. Councilman Moore noted a previous Public Works meeting in which the price from Public Safety was almost \$1 million. He questioned what was different since their current bid is lower. Operations Director Misty Micenhamer explained the bid was for updating the system instead of buying new ones. Discussion was held regarding previous bids for the siren system. Councilman Moore questioned whether the City should spend \$800,000 to replace the sirens or if they are trying to cut corners to bring the amount down. Councilman Johnson expressed concern over upgrading the system because upgrading has been done before and the goal is to be safe. Ms. Micenhamer stated the original information from Federal to replace the sirens was \$752,704. Councilman Moore questioned spending the extra \$250,000 to get all new signals and new equipment that might last longer as opposed to just replacing the sirens.

*Mr.* Nicki Arnold from Public Safety Systems, Inc. discussed their proposal for the City siren system. He stated they did a demonstration between 130 and 128 decibel sirens and those who were present could tell which one was louder, regardless of what the numbers say. He added the T-128 will outperform the 2001 siren that's rated to be 130. He noted they are located in Paragould, which is only twenty minutes away. Mr. Arnold stated they are proposing to re-license a new frequency to improve range to the sirens. Councilman Dover questioned whether they can upgrade the 2001 sirens. Mr. Arnold answered yes. Councilman Frierson noted if the Council recommends replacing sirens, then the project would have to be bid again.

Councilman Moore motioned, seconded by Councilman Street, to re-bid the siren systems in order to replace all of the sirens and open the bids to anyone who wants to bid. All voted aye. He also suggested marketing the old sirens to try and re-coup some of the money spent on new sirens.

	Councilwoman	Williams noted the resolution was passed by the Finance Committee,

Councilwoman Williams noted the resolution was passed by the Finance Committee, but since then the Council has expressed concern regarding salary increases. She

stated due to the number of pay increase requests they need to determine whether to approve the raises individually or to wait until the budget process. Mayor Formon explained when Ms. Roark was hired he and Councilman Perrin promised to re-evaluate her salary after one year of service because she had the required amount of experience, but not the required degree. Ms. Roark stated she is the only city employee that was "red circled" in that she was hired below the starting position salary. She added she was hired with the understanding that the pay would be re-evaluated. Councilwoman Furr questioned whether the raise should have been addressed during the budget process for the 2008 budget. Mayor Formon stated he missed it during the budget process and Ms. Roark had to bring it to his attention. Councilman Hargis noted the City is in a deficit budget and being asked to address salary adjustments, while they do not have financial accounting. He expressed concern over adjusting the budget in any situation. Councilman Frierson stated this is not a new topic and they are stuck with it whether they like it or not because of the promise that was made. Ms. Roark noted she was hired on at \$11,000 less than Ms. Suzanne Hackney, the previous Human Resources Director. Councilman Moore stated any increases should be addressed during the budget and not during the middle of the year. Councilwoman McCall explained the Finance Committee had already approved the raise and it was in process before the last Council meeting when salary increases were discussed. She added she thinks it is unfair to Ms. Roark and to any if their raise was already in the process to be done. Councilman Street asked Councilman Perrin whether the agreement was made to re-evaluate Ms. Roark's salary. Councilman Perrin answered yes. He explained Ms. Roark had many years of experience with the State of Arkansas and this was their recommendation. Councilwoman Furr questioned how many other commitments were made in the past that will come before the Council. She added the issue is nothing personal against Ms. Roark; rather, the issue should've been addressed in the 2008 budget. Mayor Formon stated the salary is in the pay plan. He added they are just now bringing her back up to where she should be. Councilwoman McCall stated if there are any promises then it should be shut down at the committee and not at Council. Councilwoman Furr reiterated her concern about how many other promises are lingering and will be brought before Council.

Councilwoman Williams offered the ordinance for first reading.

Councilman Dover asked Finance Director Jim Barksdale to clarify the ordinance. He stated he would like everyone to understand exactly what will be done. Mayor Formon noted the cleanup ordinance has been voted down once before and questioned whether there are any special procedures as to what needs to be done to bring it back up. City Clerk Donna Jackson stated the ordinance is new. Mr. Barksdale explained the ordinance will correct a lot of the appropriations for items, mostly Capital items, that were approved by the Council but were omitted from the budget as far as appropriations. Councilman McCall questioned whether all of the items were approved by the Council. Mr. Barksdale answered no, the appropriations have not been voted on and approved; however, many of the items were approved in 2006 but the appropriations lapsed at the end of 2006 and did not carry over to 2007. He added it was asked by Legislative Audit to pass the cleanup ordinance before they finish the 2007 audit. Mayor Formon stated all the big items went through the committee process and were approved, but the money wasn't actually placed in the budget through the year. He noted it was stated throughout the year the money could be taken care of in the cleanup ordinance. Mr. Barksdale explained the cleanup ordinance is supposed to cleanup things that the City cannot control, such as fuel. He further explained the cleanup ordinance was intended to cleanup things such as the mosquito control because that was just an omission. Councilman McCall questioned how much is not Capital Improvements. Mr. Barksdale stated almost 2/3 of the \$3 million is for Capital Improvements. Councilwoman Furr noted at a Finance meeting she was told the number might change by the end of the year. She questioned the need to pass the ordinance if the number might change. Mr. Barksdale explained they may have to make accounting adjustments, but he was told by Legislative Audit to pass the ordinance because it's a violation of state law to spend without appropriations. He added they already have a similar list made for 2008 for review by the Finance Committee on Thursday. Councilwoman Furr reiterated her question, asking whether it would make more sense to pass the ordinance after the needed adjustments have been determined by Legislative Audit. Mr. Barksdale explained there may be accounting adjustments, but it won't materially change the total amount spent. Councilman Perrin clarified Legislative Audit has mandated the City to pass the ordinance now. Mr. Barksdale answered yes. Councilman Moore questioned whether there was complete accountability for each of the items. Councilman Perrin answered yes, at one point in time.

Councilman Moore motioned, seconded by Councilman Perrin, to suspend the rules and waive the second and third readings. All voted aye.

*Mr.* Jeff Owens explained the person will be used to work at several locations with the primary goal to bring more people to the Allen Park tennis complex. the individual. Mr. Owens answered no. He explained the Parks Department is not creating a new position with any liability to the City.

Mayor Formon questioned whether they have dumpsters or roll offs. Mr. Jumper stated they have roll offs. Mayor Formon explained they are still considered commercial. Councilman Moore noted WCA will dump the roll offs for the Legion.

*Mr.* Larry Jackson commended the Council for their work with the tornado sirens. He also discussed the 4th of July festivities at Craighead Forest. He noted they received a lot of compliments and had one of the best fireworks shows they've had out there. Mr. Jackson also thanked the Council for adding the fourth week of vacation for employees.

Councilman Perrin thanked everyone for their work for 4th in the Forest. Councilman McCall noted the reason it was free this year because A&P would not provide money for events were an attendance fee is charged.

Mayor Formon discussed the leftover money from the cafeteria plan from previous years. He explained the Employee Representative Committee decided to use the leftover money for a one year membership for all employees to Air Evac. He questioned whether it needed to be bid out. Mr. Crego answered yes because normal procedures have to be met due to it still being City money.
