for and in consideration of the benefits to accrue to us, do hereby dedicate to the Public Use forever, the said above described tract of land to be used as a public street forever, the same to be known and designated and hereafter referred to as Ford Avenue.

And I, Myrtis R. Ford, wife of said Verlon Ford, for the consideration hereinabove contained and expressed, do hereby join in this dedication for the purpose of releasing any right or possibility of dower and homestead I might have or claim to have inconsistent with said dedication.

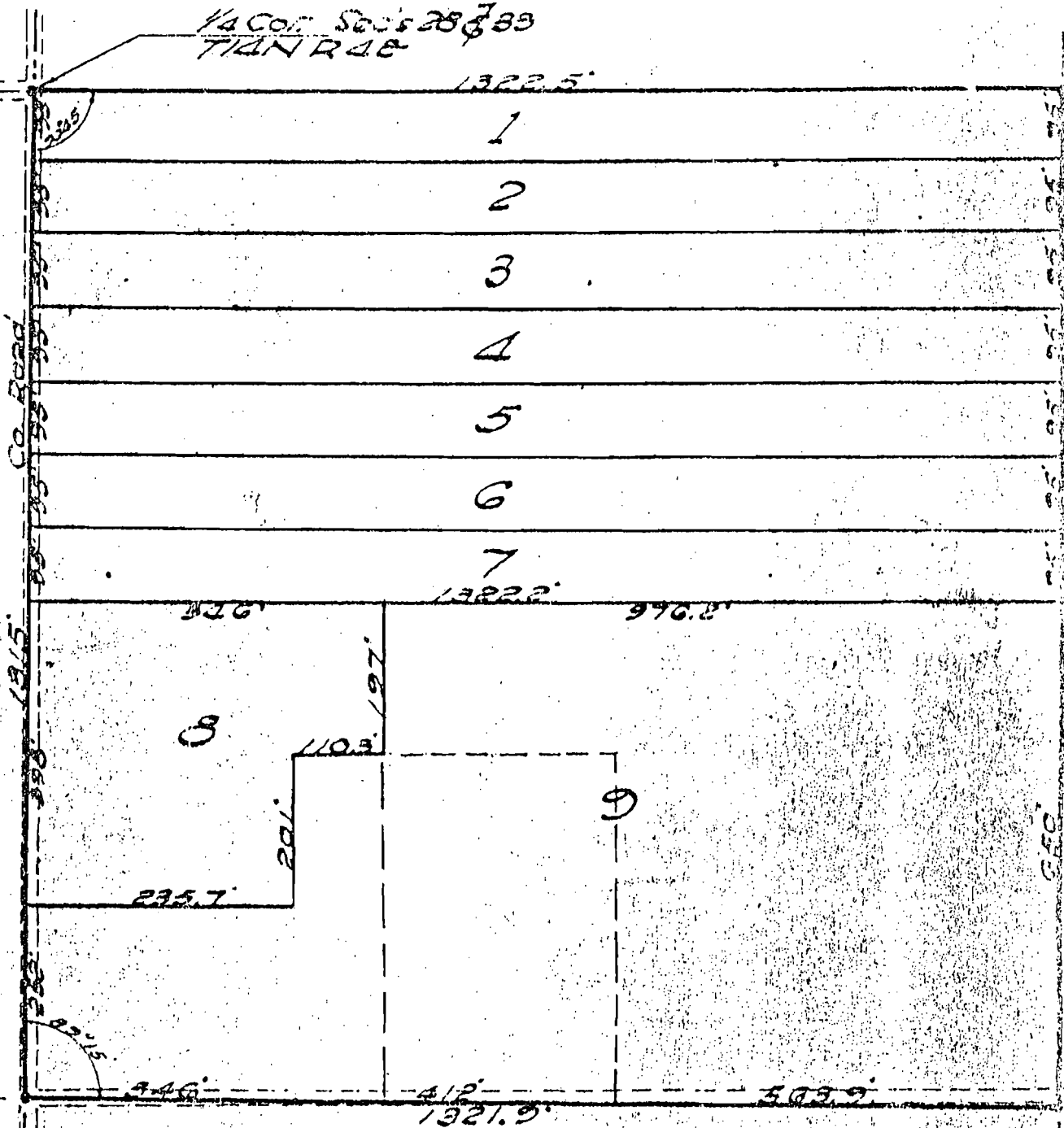
