The undersigned, being the majority of the owners of the following described real property located in Craighead County, Arkansas, to wit:

L E G A L D E S C R I P T I O N

That part of the South Half of the Southeast Quarter (S1/2, SE1/4) of Section 16 lying south and east of the southerly right of way of the St. Louis and Southwestern Railroad AND; All that part of Section 21 lying south and east of the St. Louis and Southwestern Railroad, AND; All of Section 28, AND; the West Half (W1/2) of Section 33, all in Township 14 North, Range 3 East, of the 5th Principal Meridian in Craighead County, Arkansas, AND;

The West Half (W1/2) of Section 4 and all of the Southeast Quarter (SE1/4) of Section 4 LESS AND EXCEPT the North 300 feet thereof, AND; all that part of Section 9 lying north of a line 300 feet south of and parallel to the north line of said Section 9, all in Township 13 North, Range 3 East of the 5th Principal Meridian in Craighead County, Arkansas, all more particularly described as follows;

From the northeast corner of Section 21, Township 14 North, Range 3 East, the Point of Beginning;

Thence south along the east line of Section 21, Township 14 North, Range 3 East to the southeast corner thereof, continue thence south along the east line of Section 28, Township 14 North, Range 3 East to the southeast corner thereof, thence west along the south line of said Section 28 to the southwest corner of the Southeast Quarter thereof, thence south along the east line of the West Half of Section 33, Township 14 North, Range 3 East to the southeast corner thereof, thence west some 83 feet, more or less, along the south line of the West Half of said Section 33 to the northeast corner of the Northwest Quarter of Section 4,

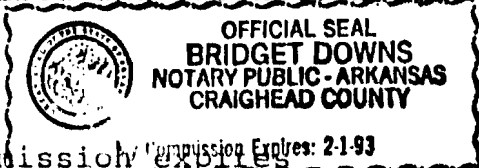

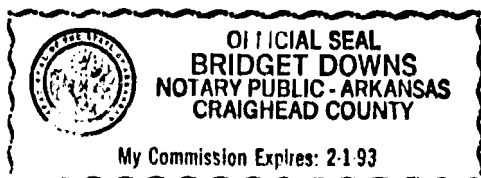

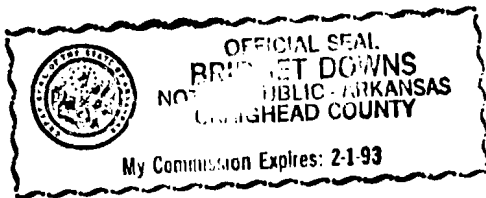
