SUBLEASE AGREEMENT

This Sublease Agreement ("Sublease") is made this 16th day of May, 2025, by and between C & A Holdings Jboro, LLC, an Arkansas limited liability company, with a principal business address at 216 Gulley Dr., Brookland, AR 72417 ("Sublessor"), and Slate Association, an Arkansas nonprofit corporation, with its principal place of business at 2411 Race Street, Suite A, Jonesboro, Arkansas 72401 ("Sublessee").

1. Premises

Sublessor hereby subleases to Sublessee, and Sublessee hereby rents from Sublessor, the premises located at 2411 Race Street, Suite A, Jonesboro, Arkansas 72401, consisting of approximately 1,639 square feet, together with all improvements and fixtures therein (the "Premises").

2. Term

The term of this Sublease shall commence on May 16, 2025, and run concurrent with the master lease with options to renew.

3. Use of Premises

Sublessee shall use the Premises exclusively for the operation of a restaurant, including but not limited to the sale of food and beverages, including alcoholic beverages subject to proper licensure by the Arkansas Alcoholic Beverage Control Board. Sublessee agrees to maintain compliance with all applicable state and local laws, and any rules of the Arkansas ABC Board.

4. Rent

Sublessee shall pay to Sublessor rent in the amount of **\$5,000.00 per month** for years 1-5 and **\$5,250.00 per month** for years 6-10, payable on or before the 5th of each month. Rent shall be paid to:

C & A Holdings Jboro, LLC 216 Gulley Dr. Brookland, AR 72417

5. Acceptance of Premises

Sublessee acknowledges that it has inspected the Premises and accepts them in their current "AS IS" condition.

6. Compliance with Master Lease

This Sublease is subject to all terms and conditions of the Master Lease between Fair Park Crossing, LLC and Sublessor dated February 1, 2025. Sublessee agrees to assume and be bound by all applicable obligations of Sublessor under the Master Lease, except for payment of rent to Lessor. Sublessee shall not do anything which would constitute a breach of the Master Lease.

7. Insurance

Sublessee shall maintain public liability insurance in the amount of at least \$1,000,000 per occurrence, naming both Sublessor and Lessor as additional insureds.

8. Alterations

Sublessee shall not make any structural alterations without prior written consent of Sublessor and Lessor. All alterations must comply with local codes and ABC regulations.

9. Liquor License Purpose

This Sublease is being executed for the purpose of facilitating Sublessee's application for a liquor license from the Arkansas Alcoholic Beverage Control Board. Sublessor acknowledges and consents to Sublessee's application and use of the Premises for the lawful sale and service of alcohol under a nonprofit permit.

10. Default

In the event of default by Sublessee, Sublessor may terminate this Sublease upon written notice and pursue all remedies available under Arkansas law.

11. Consent by Lessor

This Sublease is contingent upon the written consent of Fair Park Crossing, LLC, the Lessor under the Master Lease. Sublessor shall be responsible for obtaining such consent and attaching it as **Exhibit A**.

12. Miscellaneous

- Governing Law: This agreement shall be governed by the laws of the State of Arkansas.
- Entire Agreement: This Sublease contains the entire agreement between the parties.
- Notices: All notices shall be sent by certified mail to the addresses listed above.
