Assistant to the Parks Director Wixson Huffstetler updated the Council on the Joe Mack Campbell contracts. There are six renewed contracts so far this year for a grand total of \$65,000 over ten years. In addition, First Security Bank, Arkansas State University, Nice Pak and NEA Baptist Clinic have new advertising contracts. Nice Pak has purchased advertising for three fields. Pending sponsorships include Nordex and Pepsi. The Pepsi contract is for soccer and baseball fields. They are also working on a pouring rights contract with Pepsi. The total for the Pepsi contracts will be \$50,000. Total revenue generated by sponsorship contracts between January 1, 2011 and December 31, 2020, is \$175,000. He continued to discuss the sponsorship contracts. There are five fields still open for sponsorships. Mayor Perrin noted the sponsorship contracts that were discussed are just for soccer fields. Mr. Huffstetler agreed, adding the baseball field contracts will come due in 2012 with current sponsors having the first option to renew.

Councilman Johnson offered the ordinance for first reading by title only.

Councilman Dover questioned whether City Planner Otis Spriggs has any information regarding the rezoning. Mr. Spriggs stated there was no opposition and it was unanimously approved by the MAPC. He explained the proposed rezoning property abuts a piece of property also owned by Mr. Bogan. They have a potential developer that wants to consolidate the entire property.

Councilman Street motioned, seconded by Councilman Vance, to suspend the rules and waive second reading.

Attorney Skip Mooney, representing the property owners, asked the Council to completely pass the rezoning tonight. He explained the property is sold under contract to a company intends on commercially developing the property. He further explained the Bogans do not have a lot of money and have concerns with a proposed new federal tax bill. If the property closes before the end of the year, it will save the property owners money due to the new tax that starts January 1st. He noted there is no objection to the rezoning. Councilman Vance questioned the tax bill, stating Congress didn't pass the bill. Mr. Mooney stated that is true, but he didn't know what that means. Councilman Vance stated if the bill didn't pass, then the tax will remain the same for 2011 as it is for 2010. Mr. Mooney stated he is not sure what will happen, adding the bill could pass in January. He explained the property owners want to be absolutely sure the rezoning is passed before any tax law changes.

Councilman Frierson motioned, seconded Councilman Hargis, to amend the motion to suspend the rules for the third reading.

Councilman Street expressed concern about setting a precedent for future rezonings.

City Clerk Donna Jackson noted there is a previous motion that has not been voted on. She recommended voting on the previous motion before moving on. Councilman Frierson withdrew his motion in order to vote on the previous motion made by Councilman Street.

Mr. Jay Max Van Hoose, representing Harps, discussed the rezoning. He noted they have had two town hall meetings, as well as discussed the rezoning with the MAPC twice. They made changes to the plans due to the town hall meetings and concerns expressed by nearby residents. He noted the MAPC still has to approve the site plan if the rezoning passes.

City Attorney Phillip Crego read the ordinance for the second time.

Ms. Mary Appleton spoke in favor of the rezoning. She stated Harps has worked with the residents. She added Harps has also offered some property as greenspace.

Ms. Marcia Patton, 2111 Harrisburg Road, spoke in opposition to the rezoning. She explained Highland and Harrisburg is a vital intersection in the City and they are unsure about the number of trucks turning on Harrisburg Road. She noted ambulances use Harrisburg Road to get to Rains Street. She questioned what will happen with the greenspace if the property is sold.

Mr. Steve Skellern, 2116 Harrisburg Road, stated the intersection of Harrisburg and Highland is an F grade intersection. He added Harps has indicated they can help bring it up to a D grade, but he is unsure of whether or not they will be able to do that. He stated the traffic already backs up at that intersection at 8 a.m. and they are unable to get out of their driveway.

Councilman Dover motioned, seconded by Councilman Street, to hold the third reading for the January 18th City Council meeting.

Councilman Frierson questioned what else the Council can do considering what the MAPC has already done and why it should be held until January 18th. He stated he thinks the property owners deserve a decision before January 18th.

Councilman Dover stated in the past when there is opposition the Council allows for three readings.

Councilman Dover withdrew his motion.

Councilman Frierson motioned, seconded by Councilman Vance, to suspend the rules and waive the third reading. All voted aye, with the exception of Councilman Johnson who voted nay.

8. MAYOR'S REPORTS

Mayor Perrin reported on the following items:

Chief Financial Officer Ben Barylske emailed the financial reports for November. Revenues exceeded expenses by \$700,000. Total revenue exceeds total expenses by \$1.536 million. Sales tax revenues are \$208,822 over 2009. He noted there are still some large items that still have to be paid. He is expecting about \$500,000 in deficit spending, as opposed to the \$4.3 million deficit spending that was budgeted for 2010. He thanked the department heads for their work to keep the deficit spending down.

They have met with Crews & Associates and Stephens concerning a bond issue. He will be coming back with information if a bond issue is feasible. He stated a lot of projects could be finished with a bond issue, such as the fire station on Harrisburg Road. They are getting a legal opinion as to whether capital improvement money can be used to pay for the bonds.

The City auction brought in over \$193,000. Equipment will be purchased with the money.
