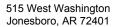

Update on 204 Floyd Street property purchase for detention pond 2008

Mayor Perrin explained the Council authorized the purchase of 204 Floyd Street in 2008 for detention work, but the property owner would have suffered a hardship with the move because he had nowhere to go. He further explained the City is just now going to move forward with the purchase of the property. He added the closing papers will indicate the residents will have to move within 90 days after signing. Mayor Perrin stated the property may not be needed for detention, so if there is excess property they are looking at applying for CDBG funding in order to build low income homes on the property.

Mayor Perrin stated the City collected \$144,000 over budget in sales tax revenues for May, which is a 2.4% increase. He added the revenues are up by \$553,000 from this time last year. He also noted the public safety tax made \$621,000 in May.

Mayor Perrin explained they are looking at freezing the Principal plan in December, 2011, in order to move forward with a defined contribution plan in January, 2012. He stated the City will be contributing the same percentage amount of money towards the defined contribution plan, but the employees will have the opportunity to contribute to the plan as well. He further explained Attorney Wyck Nisbet with Friday Eldredge and Clark will be at the next Finance meeting to discuss the retirement plan.

Mayor Perrin added the Principal plan earnings have increased and the unfunded liability has decreased to \$1.183 million. Mr. Barylske explained part of the reason for the decrease in unfunded liability is the City has lowered the pay increase assumption to 4% average, instead of the previous 6.5%. He noted after the Principal plan is frozen the City will not longer have to make payments to the plan because the plan will fund itself. Mayor Perrin stated the City will have to pay \$690,000 for the 2010 contribution, but will only do so after they meet with Stephens in order to make sure the money is invested the way the City wants it to be. He also explained they are looking at hiring a local company to cut the retirement checks in order to keep the unfunded liability low.

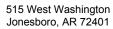

Whereas, Jonesboro, Arkansas is applying for funds under the ACED Program administered by the Arkansas Economic Development Commission, (AEDC), for an Arkansas Community and Economic Development Program project; and

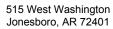
Whereas, in order to accomplish the goals and objectives of the program, it is necessary to obtain a grant administrator; and

Whereas, Jonesboro, Arkansas desires to retain the East Arkansas Planning and Development District (EAPDD) to provide administrative services, contingent upon funding by AEDC; and

Whereas, the administrative services to be performed and the cost of administration of the project shall be negotiated with the AEDC upon notification of funding approval; and

Whereas, the cost of administration shall be payable from AEDC funds and will be a part of a grant amount awarded to Jonesboro, Arkansas.

Now, therefore, be it resolved, that the Mayor of Jonesboro, Arkansas and the City Clerk are hereby authorized to contract with the EAPDD to administer the Arkansas Community and Economic Development Ike-2 Disaster Project should the City receive funding.

AGREEMENT, entered into this 1st day, by and between Michael Burroughs and the City of Jonesboro. Now whereas, the City is desirous of obtaining accountant services; KNOW THEREFORE, FOR AND IN CONSIDERATION OF THE PAYMENT OF \$_30.00_ per hour for a maximum number of _1700_ hours per year, payable on a semimonthly basis, as of July 5, 2011, I, Michael Burroughs, agree to offer my services as an Accountant in the Finance Department.

- 1. <u>TERM.</u> This contract shall continue in full force and effect from the date subscribed herein until it is deemed the services are no longer necessary.
- 2. <u>PLACE OF PERFORMANCE.</u> This Contract shall be performed within the city limits of Jonesboro, at the Mayor's request.
- 3. <u>INDEPENDENT CONTRACTOR.</u> The parties hereto do understand and agree that Michael Burroughs is an independent Contractor, not an employee of the City of Jonesboro. That neither party has the right or authority to direct or control the other or the agents in the performance of duties and each agrees to indemnify and hold the other harmless for any liability arising from their acts.
- 4. <u>ASSIGNMENT.</u> This contract is only assignable with the written consent of the parties hereto.
- 5. <u>GOVERNING LAW.</u> This contract shall be governed by the Laws of the State State of Arkansas.
- 6. <u>TOTAL INCORPORATION.</u> This agreement is the entire agreement between The parties and may only be modified by mutual agreement in writing.
- 7. <u>SAVINGS CLAUSE</u>. This agreement and individual covenants and conditions set forth herein shall be severable. In the event that any provisions shall be held void, illegal or in conflict with applicable State or Federal Law, the remaining provisions shall remain in full force and effect.
- 8. <u>WITHDRAWAL</u>. Either party may withdraw from the contract at any time, for any reason.
