ORD-15:020 AN ORDINANCE TO AMEND THE 2014 BUDGET ORDINANCE FOR THE CITY OF JONESBORO

Sponsors: Finance

Chief Financial Officer Ben Barylske stated this is the regular yearly cleanup ordinance. He explained the Street Fund was amended for the Opticom System as well as battery backups for the signals at some of the intersections in the city. The Advertising & Promotion Fund approved additional funds after passing the 2015 budget, causing the need for the cleanup of their fund. The Cemetery Fund additional funding is needed because of a new truck purchase, landscaping and surveying done by Associated Engineering. Councilman Street asked if the surveying project has been completed. Mr. Barylske answered no. Mayor Perrin stated they still have to take the information they received and coordinate it with the deeds at the Circuit

Clerk's Office. Councilman Street then asked if the city will be installing kiosks that will show visitors where people are buried. Mayor Perrin stated the city can't do that now because they are waiting for the project to be completed. But, once the project is completed the kiosks won't be a costly addition.

Mr. Barylske further explained overall the city came out under what was budgeted for 2015.

Mr. Barylske stated the price of the contract is not in the budget, which is why they are presenting the ordinance. Chairman Dover asked how long the audit will take. Mayor Perrin explained it will take 5-6 weeks. The company will meet with city vendors and others involved to compile information and then present a PowerPoint presentation to the Council to provide their recommendations concerning the IT system.

Councilman Street asked how often IT audits should be done. Mayor Perrin stated it depends on how many changes have taken place within the department, but it should be done every 3-4 years. He doesn't see the need to do it more than every 5 years, unless the city experiences additional growth. He further discussed the details of the audit. He noted it is strictly to review the administration and what the city does.

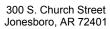
