City Planner Otis Spriggs explained there are areas within the city that are C-2 in terms of the zoning district. C-2 does not permit hotel uses. However, there are several hotels within the C-2 district. He further explained when they are faced with hotel requests in those areas they have to send the applicant to the MAPC for a conditional use approval. They are request a change in text to allow for conditional uses within the C-2 district. It will go to the MAPC for review and would be allowed as long as falls within the hotel district. Within the ordinance, they have defined the C-2 area that would allow hotels by conditional use.

Mr. Spriggs added they took this to the MAPC previously, but there was no real need for it at the time so it didn't move forward. They are proposing it again to clean up the ordinances. There is no potential development they are anticipating being affected by this at this time.

Councilman Vance asked what the alternative would be. Mr. Spriggs answered the property would have to be rezoned to C-3 or another zoning that would allow hotels. He noted another advantage of this ordinance is that it would correct any non-conforming uses in the designated areas.

Further discussion was held concerning the ordinance. Chairman Street stated this is the easiest fix. Mr. Spriggs agreed, adding this ordinance was also recommended by the MAPC.

Councilman Coleman questioned if businesses that are currently in that area would be grandfathered in. Mr. Spriggs answered yes, there are grandfather protections for businesses as they currently exist. But, they would have to go to the Board of Zoning Adjustments for approval of any changes to the property.

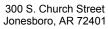

## AN ORDINANCE TO AMEND THE STREET IMPROVEMENT DRAINAGE PROGRAM MANUAL AND CREATE ADDITIONAL STREET SPECIFICATIONS

WHEREAS, the City of Jonesboro Engineering Department desires to amend the City of Jonesboro Street Improvement Program Drainage Manual adopted by ORD:2667.

WHEREAS, the City of Jonesboro held a contest for a new stormwater manhole cover design for the City. The Stormwater Management Board reviewed all entries and selected the winning entry.

WHEREAS, the Stormwater Management Board desires to adopt the winning stormwater manhole cover design to be used as an alternate to the standard cover design.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS THAT:

SECTION 1: That the Street Improvement Program Manual is amended as follows:

Drawing No. DI-6 is to be replaced with the attached DI-6 (March 2015) to match current production specifications for structures not subject to vehicular traffic and to show alternate manhole cover design.

Drawing No. DI-7 is to be inserted in the Manual for structures subject to vehicular traffic or placed in street right-of-way and to show alternate manhole cover design.

SECTION 2. That the Mayor and the City Clerk are hereby authorized by the City Council for the City of Jonesboro to adopt the above referenced changes to the Street Improvement Program Manual.




MANHOLE COVER

RING AND COVER






ALTERNATE TOP VIEW
