Chairman David McClain said, we have the appointments to the different committees for the 2020 year. As you can see within the attachments we have, we had everyone submitted their information. I think Gene may have not. I think everyone wanted to stay on the assigned committees they have had. The only ones that would need to change would be adding Chris Gibson and Charles Frierson to the Public Safety Committee. I think they are on here, but they have not been on there previously. Councilmember John Street motioned, seconded by Joe Hafner, to approve the Council Committee list as presented. Councilmember Hafner said, I do have a question. Since Mr. Vance isn't on this sheet, do we need to amend the sheet to add him to the committees he is currently on? It could have been for the ones we preferred to be on, but if he didn't submit anything, does that mean he is still on the committees? I just don't want that to be an issue since we went through this process. Chairman McClain said, right. Mayor Harold Perrin said, I thought Mr. Chairman said that basically everybody was going to stay on the same committee with the exception of. Am I correct on that? Frierson wanted to go to Public Safety. Chairman McClain said, and Chris Gibson. Mayor Perrin said, that would mean that all members now or last year would be on the same committees that they are on or will be on in 2020. Is that what I am hearing? Chairman McClain said, yes. Mayor Perrin said, I have to make a copy of this. I carry a copy of this with me all of the time. Councilmember Hafner said. I thought the motion was to make this as it was submitted and since he is not on here. Chairman McClain said, are you saying, make an amendment? Just make an amendment then. City Attorney Carol Duncan said, just make a motion to make the two changes that you requested and leave everything else. Chairman McClain said, this is reflected in this document that we have, the preferences. The preferences, the changes are made. However, Mr. Vance's, his were not included, that's it. Ms. Duncan said, I thought at the last council meeting you all said if you want to stay where you are, you didn't need to submit anything. I thought that is what you all said. Chairman McClain said, okay. Councilmember Mitch Johnson said, the last minutes reflected that he would recommend us submitting either way although it doesn't matter. Ms. Duncan said, I know. I thought at one point, I heard on this end of it, they said, so if we want to stay where we are, we don't need to turn anything in. So, I would just... Chairman McClain said, leave it as is. Ms. Duncan said, I would make a motion to make your two changes and that everyone else remains on the committees that they are currently on if it is only two changes. Chairman McClain said, okay. Councilmember Street said, if you will amend the second, I will amend the main motion to reflect that. Chairman McClain said, okay, alright. Ms. Duncan asked, is that good enough April? Councilmember Hafner asked, do we need to clarify the changes and the motion? Ms. Duncan said, yeah. It is the changes. Councilmember Hafner said, I am looking, I couldn't, okay, I will second that. I just wanted to make sure of one thing before I...

Chairman David McClain said, I have a motion and a second to forward to full council. All present voted aye.

Mayor Perrin asked, are you going to walk it on or are you going to wait until the first of February before this becomes official? The motion was to forward to full council. Chairman McClain said, yes. Mayor Perrin said, but if you all are going to start meeting on this, you made some changes on these committees. Again, you have already made the motion and the second and voted on it. Chairman McClain said, I guess we would have to reconsider adjourning. 



RESOLUTION BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS TO ESTABLISH AND APPOINT MEMBERS TO THE JONESBORO COMMITTEE ON HOMELESSNESS WHEREAS, homelessness is a social concern throughout the nation and in the City of Jonesboro; and,

WHEREAS, it is necessary to study the effects of homelessness on an individual, societal, and fiscal level within the City of Jonesboro; and,

WHEREAS, the need exists to identify and coordinate available services currently being offered in the City of Jonesboro within the faith-based community, non-profits, and other community agencies; and,

WHEREAS, the City of Jonesboro would benefit from a strategic plan solely directed at making a viable, lasting impact on chronic homelessness in the City that addresses community outreach and engagement, individual identification of needs to reduce duplication of services, long term advocacy and awareness, community policing, and the like; and,

WHEREAS, a standing advisory committee would be beneficial in reviewing homelessness in the City of Jonesboro aimed at addressing the issues above and providing advice to the Mayor and the City Council.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS THAT:

Section 1: The Jonesboro Committee on Homelessness is hereby created.

Section 2: The Committees purpose is to establish a viable plan of action to impact chronic homelessness in the City of Jonesboro. The plan of action of the Committee will attempt to address various issues surrounding homelessness, including, but not limited to: identifying the homeless population and assessing needs and capabilities; considering ways to streamline a process of assistance in order to prevent the duplication of efforts and services within community agencies, non-profits, and the faith-based community; reviewing opportunities for funding on state and federal initiative to address homelessness; identifying housing, medical, legal,

financial, and other service needs of the homeless population; assessing the costs to the community, be it from policing or other fiscal demands; providing input on legislative issues regarding chronic homelessness; and any other information relative to this issue that can be gleaned during the Committees review and assessment. The Committee will make non-binding recommendations to the Mayor and City Council regarding a strategic course of action when appropriate.

Section 3: The following are hereby confirmed to serve on the Committee: Jon Hubbard, Michael Sullivan, Stephani Berry, Rachel Thompson, Tiffany Gipson, Jerry Halsey, Jr., Casey Kidd, Jeff Steiling, Gina Wells, Jana Burnett, Gwen Zugarek, Josh Wilcoxson, Jimmie Lambert, Loretta Brewer, Marvin Day, and Dana Moore.

Section 4: The terms for all members will expire when the responsibilities are fully satisfied.

Section 5: There is a dedicated fund established in the city budget to receive contributions and other funds to be used for this purpose.
