additional work revised. It was for \$13,464.64. Councilmember Moore said, thank you. Chief Operating Officer Tony Thomas approached the podium and said, I'm not sure if Engineering Director Craig Light is online, but primarily, there was a flaw in the design that was provided to the architect when this was designed. So, this is actually to correct the design based upon the conditions that were found in the field. City Clerk April Leggett said, Tony, I don't see him online. Mr. Thomas said, Alright, I know he had a conflict this afternoon, but again, I don't know all the exact terminology. When the architect designed it, he had a set of drawings that had the incorrect information based upon what was on the ground. When they started the work, the contractor found conditions on the ground that didn't match. So, we just had to go back and get a design that was consistent with what was in the field. Chairman Johnson said, So, it was a soil condition it sounds like. Mr. Thomas said, It required some additional concrete, some additional rebar, and some conditional items that insured that the footings on that site will support the building that's being constructed. Councilmember Moore said, Thank you. I just wanted to make sure that the minutes reflected the reason for a change order.
