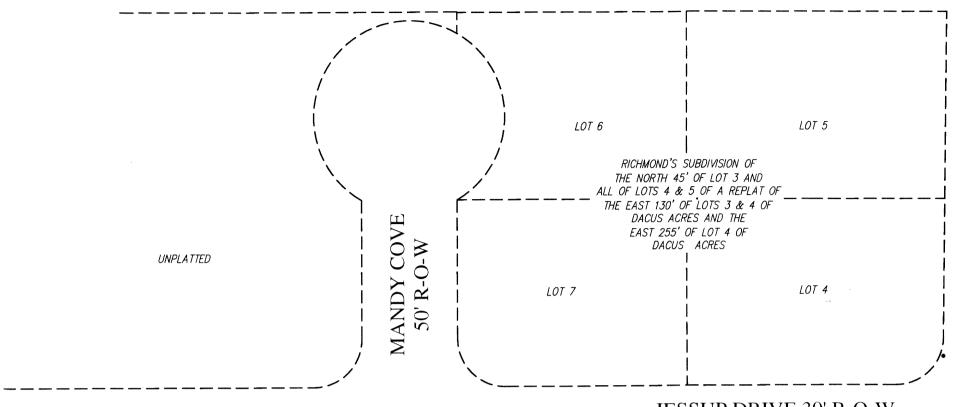

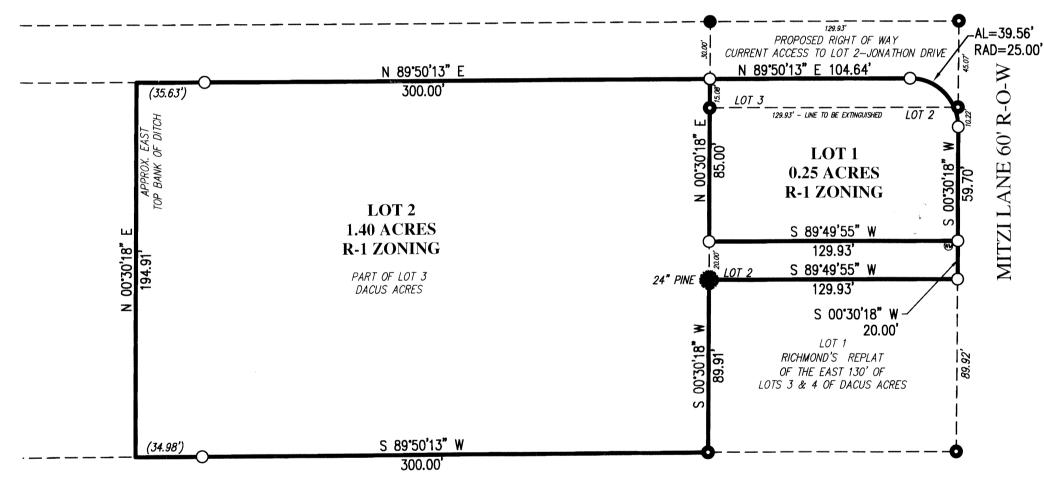

#### **LEGAL DESCRIPTION**

ALL OF LOT 2 AND THE SOUTH 45 FEET OF LOT 3 OF RICHMOND'S REPLAT OF THE EAST 130 FEET OF LOTS 3 & 4 OF DACUS ACRES, JONESBORO ARKANSAS AND PART OF LOT 3 OF DACUS ACRES, JONESBORO, ARKANSAS BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

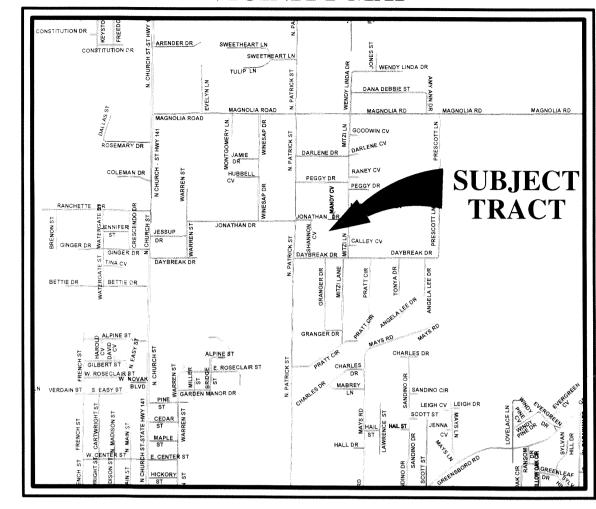
