Councilmember Joe Hafner entered the City Council Chambers and the City Council meeting at approximately 5:34 p.m. He was present in time for discussion and voting starting with RES-21:069.

Mayor Harold Copenhaver asked Community Development Director Regina Burkett to come up and give an update on what the general response from the public has been on this. Ms. Burkett explained that the 30-day public comment will be open until May 20, 2021. We did put out a survey on our website and as of today we have received 440 responses, and that is the most we've had on anything since I have been with the city which has been about two years. The top three items that people seemed to have the most concerns about are trails/parks, drainage issues, and homelessness. If anyone has not taken the survey, please go to our website and do so.

Councilmember Bobby Long asked, how are the CDBG projects prioritized? The reason for this question is based on the recent and past rains that we have gotten and the city's drainage issues. It seems that we grapple with these same issues over and over. The top three projects that you mentioned above, it doesn't seem feasible to put money into one particular area when we have infrastructure issues that are pressing our city at this point. Ms. Burkett explained, we kind of just take in what we did last year because the action plan has to be turned in by a certain date and that was done prior to the public comment. So, what we will do is go back and make an amendment. We will look at the top three and move forward. But, you have to remember the rehabilitation part of this includes drainage. Also, remember that is only at \$14,000 but, currently any money that is not used from the past year automatically rolls over into that rehabilitation line item. Mr. Long said, but we are talking about \$14,000 out of \$650,000. Ms. Burkett said yes, but it rolls over, for instance what we didn't use this

year, and we didn't use all of it because of COVID and it will be more than \$14,000. I believe that there is \$45,000 left in special projects, but remember we can always amend it.

Angela Williams, 4126 Hickory Circle, said, is it my understanding that part of these grants can be used for drainage issues? Ms. Burkett answered by saying yes, they can be used for drainage and infrastructure. The rehab portion of the money that we have right now can be used for drainage. The only problem that I did not address earlier was that it has to be in a LMI (low to moderate income) area and that the applicant that needs the help has to qualify under the LMI guidelines.

Mayor Copenhaver said to follow up on what Ms. Burkett has stated, he and his staff went out into your neighborhood Ms. Williams and we looked at the drainage issues on Hickory and in continued conversation with Craig Light, City Engineer and Derrel Smith the Planning Director, we will be getting back to you in regards to the drainage issues in your neighborhood as we move forward.

8. MAYOR'S REPORTS

Mayor Harold Copenhaver stated he would like to honor two people that we lost this week. The first one is Phillip Crego. Phillip served as the City Attorney for twenty years. Mr. Crego saw a lot of growth in the City Attorney's Office as well as the city itself. He hired Carol Duncan, the current City Attorney, to help with the growing duties of the city attorney's office. He will be missed by all that knew and worked with him. Also "Pop" Gibson died this week. Pop was one of the pioneers for Jonesboro Softball. He helped run the Southside Softball Complex for a number of years and helped bring it into what it is now. Our condolences go out to both of these families and we send them all our love.

Last weekend marked the deadline for the Youth Council applications. We were anticipating around 28 applications and we received over 50 applications. We are excited about where this will go and we want Councilmembers to participate. Ms. Shelly Anderson in my office will be administering a lot of the duties regarding this program.

We have been taking trips out into the Industrial area of our city. Thanks to a collaborative effort with Delta Peanut Company and Tommy Jumper, the city is conducting a trial project by using a byproduct of Delta Peanut to be used at the City incinerator for lower emission and a less expensive alternative for the fire in the incinerator. It also means that the fire will burn cleaner and hotter. Initial tests have been promising and we believe this can be an efficient and effective partnership. Additional collaborative efforts with other corporations and industries in this community are coming forward.

My leadership team and I met with Congressman Rick Crawford this morning. We had a lengthy conversation about this community and how he can assist us in moving it forward in Washington. Later this week, we will also be meeting with Senator John Boozeman as well. These are key officials that can be the voice for this community in Washington D.C.

We are listening and continuing to listen to the concerns of people in the community regarding drainage and other concerns. We are constantly working on efforts to help resolve these issues. Street Department Director Steve Tippitt and Engineering

Director Craig Light have been looking at our retention ponds to come up with an action plan on how to update them and keep them clean.

I want to tell you thank you again on the efforts to "Keep Jonesboro Beautiful" campaign. Last weekend, we had another major litter pickup out on Interstate I-555. We appreciate the work of Breaking Bonds Ministries and the city's Street Department. I also want to acknowledge Councilmember David McClain and the cleanup team in Valley View last weekend as well. We need more of these.

Chief Building Inspector Tim Renshaw reported to me today that we received \$13.6 million in new building permits for the month of April. That means that Jonesboro is still growing and that is good news especially considering what we have been through in the last 15 months.

This past week we had an Oasis Arts Festival downtown and I can tell you it was fabulous. I was there around three hours and it was great. We saw some young and amazing talent in our community and I want to congratulate the Downtown Jonesboro Alliance Group for pulling this off. I also want to say something that is not said enough, I'd like to read a thank you letter that was sent to us by a resident from Sage Meadows. In the letter, she said, I want to thank you for addressing the sinkhole in my yard. The crew members from the Street Department were kind and professional in every aspect of the way, and I am proud to live in this community that takes care of people. I would like to again commend our Street Department as well as all of the other departments within the city for the way they treat people. They don't get told that often enough.

Finally, this Sunday, May 9th is Mother's Day. I would be remissed if I did not remember all of our mothers, soon to be mother's, and mother's that are looking down up on us from above. Happy Mother's Day.
