My name is DeShawnna DeFord and I live at 3516 Beacon St. Jonesboro, AR 72404.

I'm writing you today to express my support for the Healthcare Freedom Resolution RES-21-199. On September 9, 2021, President Biden announced that all employers with 100+ employees

must mandate that all employees receive the Covid-19 vaccine. Those choosing not to receive the vaccine must provide a weekly negative Covid-19 test. Furthermore, if you are a healthcare employer, ALL employees must be vaccinated in order to continue to receive federal Medicaid and Medicare reimbursement dollars.

This mandate is unconstitutional and violates the rights of individuals. I am a responsible, competent adult. I take care of myself, eat healthy, and exercise. I should be given the choice and the freedom to make my own healthcare decisions. I'm not against vaccines at all. I get my flu vaccine every year and have had many other vaccines. But I researched those vaccines on my own. I weighed the benefits and risks. I talked to my own healthcare professional about those vaccines and decided that they were right for my health. No one decided that for me. And certainly the government didn't decide that for me either. Vaccine mandates should never be a condition of employment! Heart disease and stroke cost America nearly \$1 billion a day in medical costs and lost productivity. Where are the mandates for exercise? Where are the mandates to eat healthy? Where are the mandates to quit smoking? Exposure to secondhand smoke causes an estimated 41,000 deaths each year among adults in the United States: Secondhand smoke causes 7,333 annual deaths from lung cancer. Secondhand smoke causes 33,951 annual deaths from heart disease. But yet, no government mandates on this. See where I'm going?!

I work in Human Resources. Trust me when I say, finding employees who want to work – well it's almost impossible. The strain and stress it has put on our existing workforce coupled with the stressors of everyday life means our staff as well as myself are exhausted. Our mental health has suffered. And now, this Administration wants to make matters worse by mandating a vaccine. This will pinned the employer against the employee. We will have employees leave because either they can work for an employer with less than 100 employees or they will decide that they can open their own business or that they will just stay at home. These mandates will put a strain on an already tired workforce just trying to get back to surviving after being shut down.

Data released on 9/14 by the Centers for Disease Control and Prevention (CDC) showed that between Dec. 14, 2020 and Sept. 3, 2021, a total of 675,593 adverse events following COVID vaccines were reported to the Vaccine Adverse Event Reporting System (VAERS). The data included a total of 14,506 reports of deaths — an increase of 595 over the previous week. There were 88,171 reports of serious injuries, including the reports of deaths, during the same time period — up 2,200 compared with the previous week. Excluding "foreign reports" filed in VAERS, 539,473 adverse events, including 6,577 deaths and 41,840 serious injuries, were reported in the U.S. between Dec. 14, 2020 and Sept. 3, 2021. Of the 6,577 U.S. deaths reported as of Sept. 3, 12% occurred within 24 hours of vaccination, 18% occurred within 48 hours of vaccination and 31% occurred in people who experienced an onset of symptoms within 48 hours of being vaccinated.

I include the above to say this – people should be given all the information and statistics and they should be given the right to decide if they want to take a vaccine or not. This should be their choice and only their choice. Not the choice of their employer or any type of government entity. Ever!

I leave you with this. I have a friend who took the vaccine without having all the data, the potential side effects, etc. She did what she thought was right and a little bit of peer pressure. She now has tremors and unbelievable pain in her arms and legs due to the adverse reactions to the vaccine. And she has spent 1000's of dollars trying to figure out what to do and how to manage her pain. She told me she wished she would have waited and analyzed all the information and data before she took it. She made that decision, though, for herself. That was her healthcare right and freedom of choice. She regrets that decision, but she was allowed to make it. These mandates will strip that freedom away from someone like me. To Whom It May Concern,

I am emailing regarding two resolutions that have been brought to my attention: RES-21:167 and RES-21:199.

In order, RES-21:167 appears to be nothing more than an invasion of privacy and reproductive rights. There is nothing listed to prevent unwanted or knowingly dangerous pregnancies. There is evidence that areas that provide accurate sex education as well as safe and effective contriception reduce the number of unwanted

pregnancies(https://medicine.wustl.edu/news/access-to-free-birth-control-reduces-abortion-rates/). While this is an older source, it does show the effect of access to birth control. It also shows that we have known this for no less than a decade. Jonesboro could be more "Pro-life" by setting up a city-funded resource center to provide these services at no cost. The city could also meet with the school boards to encourage providing sex education there as well.

This resolution, despite stating on page 1, lines 25-27 "That the policy of the municipality is to promote and protect the dignity and humanity of all persons at all stages of life from conception until natural death;" lists no measures to aid in those that are not currently fetuses. Children in foster care, homeless individuals and families, un- and underemployed individuals, and the like are all left out of this resolution. IF we are going to be Pro-life as defined in the resolution then we MUST aid in life after birth. To not do so would be counterintuitive at best. This resolution also states on page 2 lines 29-30 " Encouraging local places of worship to promote the sanctity of human life;" would this not be bordering on the infringement of the separation of church and state? Would you not be against doing such encouragement with religious organisations if the matter being discussed went against your political opinions? Either the government is separate from religion and worship or it is not. There is no middle ground.

There are many other things I could say in regards to this resolution but I will end with this. As a mother who has lost a pregnancy, this seems as though the intentions are to guilt and coerce pregnant individuals to maintain their pregnancies at their detriment as well as remind those that lost pregnancies of their losses every time they: approach the boundaries of the municipality (D1), encounter municipal property (D3), attend a public event (D6), encounter a publicly owned vehicle (D8), and encounter a monument/memorial (D12). This funding could be better used to prevent loss of life and pregnancy in other ways.

RES-21:199 appears to be in direct contrast to RES-21:167. If we are going to be "Pro-life" then surely we must protect those that would be vulnerable due to the COVID-19 pandemic. Unvaccinated individuals make up the vast majority of hospitalizations and deaths due to the virus. Additionally, the length and intensity of the pandemic is causing shortages within hospitals (labor, oxygen, medications, and space) as well as ambulances and EMTs. Have you been to an emergency department lately? I have. At NEA Baptist here in Jonesboro they are so busy that they have been forced to add hospital beds and wheelchairs to treat patients in the hall. There were no fewer than 9 of these stations as of 9/16/2021. These shortages have and will continue to cost the lives of more than "just" covid patients. We cannot simply go about our lives as if this is the new normal and simply accept any deaths and serious injuries. Research has shown that, for the vast majority of people, the vaccine is safe and effective. Are there cases of vaccine injury? Yes. Those are statistically insignificant when compared to the impact of covid. Are there breakthrough infections? Yes. Once again, the vast majority of cases (even controlling for vaccination rates) are found in unvaccinated individuals.

It is also worth noting that another way that this resolution is in direct contrast with RES-21:167 is that pregnant women are at higher risk of extreme illness due to covid according to the CDC (https://www.cdc.gov/coronavirus/2019-ncov/cases-updates/special-populations/pregnancy-data-

on-covid-19/what-cdc-is-doing.html). Research is ongoing on the effects of covid on neonates, however there is already research stating that covid antibodies are present in newborns delivered by vaccinated mothers (https://news.harvard.edu/gazette/story/2021/03/study-shows-covid-19-vaccinated-mothers-pass-antibodies-to-newborns/). There is no "Pro-life" without enforcement of public health regulations. There are already state requirements for other vaccinations in Arkansas, the covid vaccine should also be required. Perhaps we are even more obligated to require covid vaccines due to the active pandemic as well as the fact that these vaccines have been so thoroughly tested with continued monitoring by the CDC (specifically in reference to the US).

We need to encourage the vaccine now more than ever. There has been divisive language used around vaccination and as leaders in our community it is, in part, your job to combat this. Lead our community to a safer future. If you fail to see the benefit there, please consider that those that become unemployed, disabled, or die will no longer be contributing to the local economy. We will remember who fought to keep us and our families safe. Those that fight against public safety measures are sure to get their own page in the history books as well.

For those of you who are members of the Public Services Committee, I encourage you to not make a second for Res 21-199 to walk-on to the full council. If it does receive a second, I encourage you to vote against sending the resolution to the full council. If it does make its way to the full council, I encourage each of you to oppose Res 21-199.

I find it troubling that Alderman Long is, once again, more fixated on making *statements* than his is in taking *action*, via the authority actually enumerated to the Jonesboro City Council, on the issues that affect the City of Jonesboro. Political statements like Res 21:199, as well as Res 21:167, have no legal authority and just wastes the council's time when it could be spending more time in taking action on the issues it can actually change or improve for all of Jonesboro.
