Mayor Harold Copenhaver said, "Mr. Chairman if I may I'd like to make just a few comments. This has been a collaborative effort, obviously, within the city. We're hearing what the citizens of our community have requested and we're trying to provide that. We feel that through grants as well as the appropriation of the American Act proceeds can be used for this. We feel very strong and confidant in that. I would like

to also, if it's ok with council, to make a full presentation at City Council. We have a good lengthy presentation, which Officer Carmack is here as well, and she can help us do that and facilitate that by taking up time, I would like to present that if that is ok with ya'll at the full City Council meeting." Chairman Mitch Johnson said, "That would be a great idea mayor." Councilmember David McClain asked, "Would that be tonight?" Mayor Copenhaver said, "That would be in two weeks." Councilmember Bobby Long said, "I think the systems that are being proposed are past needed. I think what would be more alarming is when we hear the excellent job that these people have been doing with the resources that they have right now and how much better it could be with these systems in place. It's well worth the money. I've always said we can have all the parks and everything in the world but if we did not have safety of our public it's all in vein. I think this is something that needs to be invested in as soon as possible." Chairman Mitch Johnson said, "I think we're well beyond that point as well. These are well past needed items and I think they will take us well into the future."

Patti Lack, 4108 Forrest Hill Rd, approached the podium, "I hope that when you address City Council. I notice on here that it list and says 8 fire respirator mask but it doesn't list how many dispatcher chairs or how many headsets. I wondered if you could become specific on how many there is because when I look at chairs I see \$10,500.00. Is that like two chairs or is it 3 chairs?" Mayor Copenhaver said, "In that presentation Ms. Lack, what we will get to is exactly what you're asking and it will also go into detail more on the 911 system as a whole, because we're needing consoles for our dispatchers. In the environment that they're in obviously we need that for their protection and their health as well. We'll go into detail of how many consoles and all of that will be done in that presentation. You'll see, actually the community will see, what the current program we have in place and how this is going to overlap all of that with one complete system where as now we have 11 separate systems in place." Ms. Lack said, "I think it's a great thing that we can have this money. That would just be one of the things that would be helpful. Also two, with the camera's that will be going into the park, does that eliminate the committee that is looking for funds for the SkyCops?" Mayor Copenhaver said, "That is always ongoing because the community as well can invest in this. We'll explain that too. Like if communities want to participate and have a SkyCop in their community they can do that as well. We are going to be able to look at that and expand on this feature."
