Minutes for the special called City Council meeting on January 23, 2006 CITY COUNCIL MINUTES - January 23, 2006

The Jonesboro City Council met Monday, January 23, 2006, at 4:00 p.m. for a special called meeting. Members present were: Mayor Doug Formon, City Clerk, Donna K. Jackson, and ten council members. Those members were: Farmer, Province, Hargis, Williams, Perrin, Street, Dover, Furr, McCall and Ashley.

Mayor Formon stated the purpose for the meeting is to get financing arranged for two fire trucks so they can be used. It was stated the rate for the leased equipment would be good until February 3<sup>rd</sup>, since that is 30 days from when Bank of America quoted the rate.
