AN ORDINANCE TO AMEND TITLE 14 OF THE JONESBORO MUNICIPAL CODE KNOWN AS THE ZONING ORDINANCE PROVIDING FOR A CHANGE IN ZONE DISTRICT BOUNDARIES LOCATED EAST OF CARAWAY ROAD BETWEEN JOHNSON AND DAVIS AS REQUESTED BY BETTY SHAW BE IT ORDAINED by the City Council of the City of Jonesboro, Arkansas:

SECTION 1. That Title 14 of the Jonesboro Municipal Code known as the Zoning Ordinance of the City of Jonesboro, Arkansas, 00 be amended by the change in zone district boundaries as follows:

From R-1, Single Family Medium Density District (4.22 Acres), C-3, General Commercial District (0.58 Acres) and C-4, Neighborhood Commercial District to P.U.D.-RM, Planned Unit Development, that land described as follows:
