PART OF LOT 3, BLOCK 4 OF BROADAWAY ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF LOT 3, BLOCK 4 OF BROADAWAY ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS; THENCE NORTH 89°39'45" EAST, ALONG THE NORTH LINE OF SAID LOT 3, 102.60 FEET; THENCE SOUTH 00°25'31" WEST, LEAVING SAID NORTH LINE, 24.05 FEET; THENCE NORTH 89°33'05" WEST, 6.52 FEET; THENCE NORTH 29°59'55" WEST, 19.72 FEET; THENCE NORTH 89°32'05" WEST, 38.15 FEET; THENCE SOUTH 89°31'35" WEST, 47.98 FEET; THENCE NORTH 00°41'57" EAST, 6.41 FEET TO THE POINT OF BEGINNING, CONTAINING 865 SQ.
