LEGAL DESCRIPTION: Part of the Southwest Quarter of the Southwest Quarter of Section 23, Township 14 North, Range 4 East, more particularly described as follows: Beginning at a point 165 feet South and 510 feet West of the Northwest corner of said Southwest Quarter of the Southwest Quarter; thence West 55 feet; thence South 165 feet; thence East 55 feet; thence North 165 feet to the point of beginning.

WHEREAS, JULIA FORMON, the owner of record, was properly notified of a code violation at MORTON, 01 -144233-03000, Jonesboro, AR 72401, and refused to remove or correct the conditions identified by the code enforcement officer of the City of Jonesboro, Arkansas; and,
