PART OF LOT 8 OF SOUTHWEST SUBURBAN ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF LOT 8, SOUTHWEST SUBURBAN ADDITION TO THE CITY OF JONESBORO, CRAIGHEAD COUNTY, ARKANSAS; THENCE SOUTH 89°35'13" WEST, 19.25 FEET; THENCE NORTH 00°44'51" EAST, 140.64 FEET; THENCE NORTH 89°03'24" EAST, 19.26 FEET TO THE EAST LINE OF SAID LOT 8; THENCE SOUTH 00°44'51" WEST, ALONG SAID EAST LINE, 140.82 FEET TO THE POINT OF BEGINNING, CONTAINING 2,709 SQ.
