A RESOLUTION TO SET A PUBLIC HEARING REGARDING THE ABANDONMENT OF HAL STREET AS REQUESTED BY JOSH HURD WITH MCALISTER ENGINEERING ON BEHALF OF BOB REES WHEREAS, Bob Rees, has filed a petition with the City Clerk of the City of Jonesboro, Arkansas, requesting that the City abandon a public street in:

ALL OF HAL STREET (APPROXIMATELY 140') FROM THE NORTHERLY RIGHT OF WAY OF HIGHLAND PARK CIRCLE TO THE END OF THE CURRENTLY PLATTED HAL STREET AS SHOWN ON PLAT FOR HIGHLAND SUBDIVISION PHASE II IN PLAT BOOK C AT PAGE 119 IN THE OFFICE OF THE CIRCUIT CLERK FOR CRAIGHEAD COUNTY IN JONESBORO, ARKANSAS. RIGHT OF WAY TO BE REPLACED IN ITS ENTIRETY WITH A 75' COMBINED INGRESS / EGRESS / UTILITY EASEMENT TO ACCOMODATE EXISTING AND FUTURE UTILITIES.

WHEREAS, the petition has been presented to the City of Jonesboro, Arkansas; and

WHEREAS, Arkansas law requires notice of such public hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Jonesboro, Arkansas, that the City Clerk is directed to publish a notice advising the public of such request to abandon the above mentioned street and that this matter will be heard before the City Council on September 4, at 5:20 p.m. at the Municipal Building, Jonesboro, Arkansas.
