WHEREAS, the City of Jonesboro has desires to accept the low bid and enter into a contract for the Nettleton Avenue Drainage Improvements project;

WHEREAS, the low bidder and the firm selected for the Nettleton Avenue Drainage Improvements project is Cameron Construction Co., Inc.;

WHEREAS, Cameron Construction Co., Inc. has bid \$442,052.50 for the Nettleton Avenue Drainage Improvements project;

WHEREAS, the funding for the execution of the contract shall come from 07-100-0152-07 and compensation shall be paid in accordance with the contract documents.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS THAT:

Section 1: That the City of Jonesboro shall accept the low bid and enter into a contract with Cameron Construction Co., Inc. in the amount of \$442,052.50 for the Nettleton Avenue Drainage Improvements project

Section 2: The funding for the execution of the contract shall come from 07-100-0152-07 and compensation shall be paid in accordance with the contract documents

Section 3: The Mayor and the City Clerk are hereby authorized by the City Council for the City of Jonesboro

to execute all documents necessary to effectuate this agreement.
