A RESOLUTION OF THE CITY OF JONESBORO, ARKANSAS TO ALLOCATE AMERICAN RESCUE PLAN FUNDS TO PURCHASE A FILTER \& HEATING SYSTEM FOR THE JONESBORO CITY POOL WHEREAS, the Parks Department desires to purchase equipment to allow for more open-air exercise and take steps to reduce illness transmission; and

WHEREAS, the City of Jonesboro took bids and the lowest bidder was Clarity Pools in the amount of \$83,901.59; and

WHEREAS, based off current guidelines, this expenditure follows qualification standards for American Rescue Plan funding.
