LEGAL DESCRIPTION: Part of the Southwest Quarter of the Northeast Quarter of Section 12, Township 14 North, Range 3 East, Craighead County, Arkansas, described as follows: Begin at the point of intersection of the East line of said Southwest Quarter of the Northeast Quarter and the extended fence line between old Pierson property on the North and the old Hinson property on the South (same being the ACCEPTED/AGREED Northeast corner of said Southwest Quarter of the Northeast Quarter, thence West 15 feet to the centerline of Duncan Road; thence South 560 feet to the point of beginning proper, being a point located on the South line of a lot formerly owned by James Garfield Slaven; thence West 180 feet; thence South 80 feet; thence East 180 feet to a point that is 596.3 feet South of the ACTUAL Northeast corner AND 640 feet

South of the ACCEPTED/AGREED Northeast corner of said Southwest Quarter of the Northeast Quarter (according to a June 3, 1985 Survey by Troy L. Sheets Surveying); thence North 80 feet to the point of beginning proper, and being subject to public road easement along the East side thereof.

WHEREAS, the above property has been inspected and has been determined unsuited for human habitation.

WHEREAS, all of the stipulations have been met in the condemnation process to proceed with the condemnation of this property.
