Vector Disease Control contract for mosquito spraying services  
 Vector Disease Control was awarded the contract for mosquito spraying services and was signed on April 7, 1995. The length of the contract is from January 1, 1995, to December 31, 1999, and shall be renewed for four (4) subsequent years. The prices are detailed in the contract. The ordinance number is 2615 and was approved by the City Council on March 20, 1995.

The contract was renewed a second time and is from January 1, 1997, to December 31, 1997, and shall be renewed for nine (9) subsequent renewal terms of one year. The prices are detailed in the contract.

The contract was renewed again and is from January 1, 2007, to December 31, 2007, and shall be automatically renewed for four (4) subsequent years. The prices are detailed in the contract. The ordinance number is ORD-07:1183 and was approved by the City Council on July 26, 2007.

The contract was renewed again and is from January 1, 2012, to December 13, 2012, and shall be renewed automatically each year for a maximum of (6) years and was signed on January 3, 2012. The prices for each year are listed in the contract. The resolution number is RES-11:221 and was approved by Council on January 3, 2012. An amendment to this contract was approved by the City Council on November 3, 2015, by RES-15:151. The amendment provides for eight aerial applications rather than five without an increase in cost to the city. The amended contract was signed on November 18, 2015.
