## Delta Dental contract for employee dental insurance

Delta Dental was awarded the contract to provide employee dental insurance for 2008. The contract amount is \$20.21per month for single coverage and \$44.19 per month for family coverage and the City will provide single coverage for all full-time employees and if family coverage is desired the employee will pay the \$44.19 per month. The resolution number is RES-07:2561 and was approved by the City Council on December 07, 2007. No contract was provided.

The contract was extended to include 2009. The contract amount is \$22.64 per month for single coverage and \$72.14 per month for family coverage. The City will provide single coverage for all full time employees and if family coverage is desired the employee will pay \$49.50 a month. The resolution number is RES-08:211 and was approved by the City Council on December 2, 2008.

The contract was extended a second time to include 2010. The contract amount is \$22.19 per month for single coverage and \$70.70 per month for family coverage. The City will provide single coverage for all full time employees and elected officials and if family coverage is desired the employees will pay \$48.51. The resolution number is RES-09:180 and was approved by the City Council on December 16, 2009.

The contract was extended a third time to include 2011. The contract amount is \$24.20 for single coverage and \$77.06 per month for family coverage. The City will provide single coverage for all full time eligible employees and if family coverage is desired the employee will pay \$52.86 per month. The resolution number is RES-10:160 and was approved by the City Council on December 7, 2010.

The contract was extended a fourth time to include 2013. The contract amount is \$26.14 per month for single coverage and \$83.22 for family coverage. The City will provide single coverage for all full time employees and elected officials and if family coverage is desired the employee will pay \$57.08. The resolution number is RES-12:200 and was approved by Council on November 20, 2012.

Delta Dental was awarded the 2016 contract to provide dental insurance for the city's employees. The ordinance is ORD-15:062 and was approved by the City Council on December 1, 2015. No contracts were provided.
