AN ORDINANCE TO AMEND ORDINANCE NO. 1664 OF THE CITY OF JONESBORO, ARKANSAS, THE SAME DEALING WITH LICENSE AND PRIVILEGE TAXES BE IT ORDAINED by the City Council of the City of Jonesboro, Arkansas:

Section 1: The following categories shall be amended as follows:

#34 CATALOG HOUSES, All persons selling by catalog and storing in and distributing goods \$250.00.

#77 GASOLINE FILLING STATIONS, Delete (c) which is an additional \$12.00 fee for mechanical tune-up and repair
