WHEREAS, The City of Jonesboro, Arkansas desires to negotiate drainage easement on the property located at <u>Jonesboro School District No. 1</u>, Jonesboro, Arkansas for the purpose of creating a detention pond; And

The Mayor and City Clerk are hereby authorized to execute the documents necessary to complete this transaction at a total price of \$147,539.71 to come from existing appropriations for City Drainage Projects, Account Number 07-100-0152-00. The City of Jonesboro shall furnish a Warranty Deed upon closing.
