NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Jonesboro, Arkansas that the City Clerk is directed to publish a notice once a week for two consecutive weeks advising the public of the request by the property owners to vacate and abandon the utility and drainage easements mentioned above and this matter will be heard before the City Council on May 3, 2004 at 6:00 p.m. p.m. o'clock in Council Chambers, located at 900 W. Monroe, Jonesboro, Arkansas.
