PART OF LOT 7, BLOCK 4 OF BROADAWAY ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF LOT 7, BLOCK 4 OF BROADAWAY ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS; THENCE NORTH 89°39'45" EAST, ALONG THE NORTH LINE OF SAID LOT 7, 102.60 FEET; THENCE SOUTH 00°41'57" WEST, LEAVING SAID NORTH LINE, 6.41 FEET; THENCE SOUTH 89°31'35" WEST, 102.62 FEET; THENCE NORTH 00°50'04" EAST, 6.65 FEET TO THE POINT OF BEGINNING, CONTAINING 670 SQ. FT., MORE OR LESS, SUBJECT TO ALL RIGHTS-OF-WAY AND EASEMENTS OF RECORD.
