A RESOLUTION BY THE CITY COUNCIL OF JONESBORO, ARKANSAS AUTHORIZING THE OFFER AND ACCEPTANCE TO PURCHASE ADDITIONAL RIGHT-OF-WAY AT 2301 ENGLEWOOD COVE FOR THE PURPOSE OF THE CONSTRUCTING AND MAINTAINING DRAINAGE IMPROVEMENTS WHEREAS, the City of Jonesboro, Arkansas desires to purchase the following described right-of-way for the purpose of constructing and maintaining drainage improvements:

A PERMANENT DRAINAGE EASEMENT BEING A PART OF LOT 29 OF FOXMEADOW VILLAGE THIRD ADDITION TO THE CITY OF JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF LOT 29 OF FOXMEADOW VILLAGE THIRD ADDITION TO THE CITY OF JONESBORO, CRAIGHEAD COUNTY, ARKANSAS; THENCE NORTH 02°44'00" WEST, 15.02 FEET TO THE POINT OF BEGINNING PROPER; THENCE CONTINUE NORTH 02°44'00" WEST, 11.17 FEET; THENCE SOUTH 89°59'38" EAST, 19.80 FEET; THENCE SOUTH 00°00'22" WEST, 11.15 FEET; THENCE NORTH 89°59'38" WEST, 19.27 FEET TO THE POINT OF BEGINNING PROPER, CONTAINING 218 SQ. FT., MORE OR LESS, SUBJECT TO ALL RIGHTS-OF-WAY AND EASEMENTS OF RECORD.
