AN ORDINANCE TO WAIVE COMPETITIVE BIDDING AND AUTHORIZE DENNIS NEAL RESURFACING TO EPOXY RESIN FINISH FIVE SETS OF RESTROOMS AT CRAIGHEAD FOREST PARK FOR THE PARKS DEPARTMENT

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF JONESBORO, ARKANSAS:

<u>Section 1.</u> That the Parks Department of the City of Jonesboro, Arkansas needs to purchase the services of Dennis Neal Resurfacing to Epoxy Resin Finish floors and half walls at all 5 sets of restroom located at Craighead Forest Park.

<u>Section 2.</u> That said service may be purchased from Dennis Neal Resurfacing located in Swifton, Arkansas, for the sum of \$38,669.00 to be paid from the 2020 Capital Improvement Budget.

<u>Section 3.</u> The City of Jonesboro in accordance with the terms of A.C.A. Section 14-58-302 hereby waive the requirement of competitive bidding deeming it unfeasible due to the following: Dennis Neal Resurfacing is determined to be a sole source provider of this type of product and service.

<u>Section 4.</u> It is further found that due to the need of these products and services to maintain public health levels, an emergency is declared to exist and this ordinance being necessary for the preservation of the public peace, health, and safety, shall take effect from and after its passage and approval.
