RESOLUTION OF THE CITY OF JONESBORO, ARKANSAS APPROVING THE CONTRACT WITH KNISH CORPORATION FOR SIDEWALKS AND CURB CUTS UNDER THE 2002 JONESBORO DOWNTOWN SIDEWALK IMPROVEMENTS PROJECT, JOB NO. 100557 (**NOTE: THIS CONTRACT HAD A CHANGE ORDER WITH RES-04:597 ON JUNE 7, 2004; RES-05:505 ON MARCH 1, 2005**) WHEREAS, the City of Jonesboro advertised and received bids for the construction of sidewalks and curb and gutter on September 9, 2003 for the Jonesboro Downtown Sidewalk Improvements Project, Arkansas State Highway and Transportation Job No. 100557; and

WHEREAS, the low bid of \$624,557.75 was submitted by Knish Corporation which was checked and recommended by our engineer, Associated Engineering and Testing, LLC; and

WHEREAS, the Finance and Grants Committee recommended on September 18, 2003 approval of awarding a contract to Knish Corporation.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS:

THAT, the proposed contract for \$624,557.75 with Knish Corporation, attached hereto is hereby approved, and the Mayor and City Clerk be authorized to sign the contract.
