  - (A) 3<sup>rd</sup> reading - Ordinance to vacate all alleys located in Block B of Earl Kiech Second Addition (Kent Gibson)
  - (B) 3<sup>rd</sup> reading - Ordinance to rezone property from Residential (R-1) to Commercial (C-3), located on the north side of W. Washington Ave., west of Stratford Drive. (Skip Macon)
  - (C) 2<sup>nd</sup> reading - Ordinance to rezone property from Residential (R-1) to Commercial (C-4), located on the north side of Highland Drive, east of Hillcrest Drive. (J. D. Crocker)
