A RESOLUTION TO THE CITY OF JONESBORO, ARKANSAS TO AUTHORIZE THE MAYOR AND CITY CLERK TO ACCEPT A PERMANENT CONSTRUCTION EASEMENT FROM SYLVIA SHINAULT FOR THE PURPOSE OF CONSTRUCTING AND MAINTAINING A SIDEWALK

WHEREAS, the City of Jonesboro, Arkansas desires to accept the following described easement for the purpose of constructing and maintaining a sidewalk:

A PART OF LOT 8, BLOCK A OF EARL KIECH SECOND ADDITION TO THE CITY OF JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, (AS RECORDED IN BOOK 48, PAGE 218), BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHEAST CORNER OF LOT 8, BLOCK A, OF EARL KIECH SECOND ADDITION TO THE CITY OF JONESBORO, CRAIGHEAD COUNTY, ARKANSAS; THENCE SOUTH 89°50'29" WEST, ALONG THE NORTHERLY RIGHT-OF-WAY LINE OF VERA STREET, 2.95 FEET; THENCE NORTH 00°00'36" EAST, LEAVING SAID NORTHERLY RIGHT-OF-WAY LINE, 17.01; THENCE NORTH 45°00'36" EAST, 3.99 FEET TO THE WESTERLY RIGHT-OF-WAY LINE OF THORN STREET; THENCE SOUTH 00°20'50" EAST, ALONG SAID WESTERLY RIGHT-OF-WAY LINE, 19.83 FEET TO THE POINT OF BEGINNING, CONTAINING 53 SQ. FT., MORE OR LESS, SUBJECT TO ALL RIGHTS-OF-WAY AND EASEMENTS OF RECORD.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS THAT:

Section 1: The Mayor and City Clerk are hereby authorized by the City Council for the City of Jonesboro, Arkansas to accept the easement described above.
