AN ORDINANCE TO THE CITY OF JONESBORO, ARKANSAS TO AMEND THE 2016 BUDGET, ACCEPT THE LOW BID AND ISSUE A PURCHASE ORDER TO KINDER BROTHER EXCAVATING, INC. FOR RECHANNELING/MODIFYING DRAINAGE CHANNELS (2016:28); AND DECLARING AN EMERGENCY

WHEREAS, the City of Jonesboro passed the 2016 Budget in Ordinance Number 15:069, which will need to be amended to transfer funds from the Reserves to the Capital Improvement - Drainage budget in order to effectuate the acceptance of the low bid and issuing a purchase order for the rechanneling/modifying of drainage channels.

WHEREAS, the City of Jonesboro has desires to accept the low bid and issue a purchase order for the rechanneling/modifying of drainage channels to Kinder Brothers Excavating, Inc.

WHEREAS, funding for the execution of the purchase order shall come from funds allocated from the Reserves to the Capital Improvements - Drainage budget and compensation shall be paid in accordance with the bid documents.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS THAT:

SECTION 1: The 2016 Budget is hereby amended to increase in the Capital Improvements - Drainage budget by transferring money from the Reserves for the rechanneling/modifying of drainage channels.

SECTION 2: That the City of Jonesboro shall accept the low bid and issue a purchase order to Kinder Brothers Excavating, Inc. for the rechanneling/modifying of drainage channels.

SECTION 3: The City Council further finds and declares that an emergency exist and this Ordinance being
