NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS:

SECTION 1: That the Consolidated Plan/Action Plan, dated October 21, 2002, attached hereto is hereby approved.

SECTION 2: That the seventh year (2003) CDBG Projects and Budget are noted and approved as a part of the Plan.

SECTION 3: That the Mayor or Community Development Grants Coordinator is directed to sign all documents, as necessary to assure the 2003 Consolidated Plan/Action Plan is submitted to the Department of Housing and Urban Development on or about November 15, 2002.
