Minutes for the City Council meeting on July 6, 1999 CITY COUNCIL MINUTES - JULY 6, 1999

The Jonesboro City Council met Monday, July 6, 1999, at 6:30 p.m. A full quorum was in attendance. Present were: Mayor Hubert Brodell, City Attorney, Phillip Crego, City Clerk, Donna K. Jackson, and 11 council members. Those members were: Kelton, Tate, McCall, Young, Crockett, Rorex, Province, Copeland, Moore, Perrin, and Roddy. Councilman Rega was unable to attend.

Councilman Perrin moved, seconded by Councilman Crockett for approval of the minutes from June 21, 1999, as delivered. A voice vote was taken resulting in all members voting aye. Those members voting aye were: Kelton, Tate, McCall, Young, Crockett, Rorex, Province, Copeland, Moore, Perrin, and Roddy.

Mayor Brodell presented Mrs. Jan Coleman a framed copy of Resolution No. <u>1999:24</u>, adopted June 21, 1999, in honor of the late Jon Coleman for his service to the community of Jonesboro. Mrs. Coleman received a standing ovation by Council and others present at the meeting.

Mayor Brodell stated since the Street Department intends to use two existing garbage trucks, it would be necessary to reimburse the Sanitation Department for the trucks. Also Mayor Brodell stated sanitation employees would be transferred to the Street Department rather than be laid-off due to cut backs in the Sanitation Department. The cost was estimated at approximately \$300,000.00 with the funds to come from the Three Million which was appropriated to pave the streets. A voice vote was taken resulting in all members voting aye. Those members voting aye were: Kelton, Tate, McCall, Young, Crockett, Rorex, Province, Copeland, Moore, Perrin, and Roddy.

With no further business, the meeting was adjourned.
