Minutes for the City Council meeting on November 5, 1984

An Appeal Hearing was held at City Hall on November 5, 1984, at 7:00 p.m. concerning a MAPC decision at Lots 3 & 4, Block A, Noble Acres to rezone. No action by the council was taken during the hearing but later acted during the regular Council Meeting.

CITY COUNCIL MINUTES - NOVEMBER 5, 1984

The Jonesboro City Council met in regular session, Monday, November 5, 1984, at 7:30 p.m. Present were Mayor, City Clerk, City Attorney, and all aldermen.

The minutes of October 15, 1984, were approved as mailed on motion by Mr. Sanderson, seconded by Mr. Stricklin. All voted aye.

Mr. Nix offered the following ordinance: ((R-3 to C-5 Noble Acres)

AN ORDINANCE TO AMEND ORDINANCE #954 KNOWN AS THE ZONING ORDINANCE PROVIDING FOR THE CHANGE IN ZONING BOUNDARIES

Mr. Sanderson moved, seconded by Mr. Hannah, to suspend the rules and place the ordinance with the emergency clause. All voted aye. The ordinance was given the number <u>1895</u>.

The following ordinance was on 3rd reading: (R-1 to C-3 - Noble Acres)

AN ORDINANCE TO AMEND ORDINANCE #954 KNOWN AS THE ZONING ORDINANCE PROVIDING FOR THE CHANGE IN ZONING BOUNDARIES

Concerning a decision by the residents of Merrywood Subdivision, Mr. Bridger moved, seconded by Mr. Park, to accept \$20,000 cash and \$12,000 property from the developer and the city do the drainage work involved. All voted aye.

Mr. Stricklin moved, seconded by Mr. Hannah to allow trailer placement at 1325 West Jefferson. All voted aye.

Mr. Stricklin moved, seconded by Mr. Shelton to amend the Fire Department rules & regulations as on file in the Clerk's Office. All voted aye.

The following ordinance was on 2nd reading: (Colson Bond Issue)

AN ORDINANCE CONFIRMING THE AUTHORIZATION TO ISSUE INDUSTRIAL DEVELOPMENT REVENUE BONDS; AMENDING ORDINANCE #1864, PASSED AND APPROVED ON THE 16TH DAY OF APRIL, 1984, PERTAINING TO THE ISSUANCE OF SUCH BONDS; AUTHORIZING AND PRESCRIBING OTHER MATTERS PERTAINING THERETO; AND DECLARING AN EMERGENCY

Mr. Hannah moved, seconded by Mr. Sanderson, to use remaining drainage funds from Industrial Park to aid in the Higginbotham Creek project. All voted aye.
