RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JONESBORO, ARKANSAS, TO APPROVE ASSESSMENTS AS LEVIED BY THE NORTH CARAWAY ROAD STREET IMRPROVEMENT DISTRICT NO. 2

WHEREAS, the North Caraway Road Street Improvement District No. 2 was established by Ordinance No. 2197; and

WHEREAS, the Board of Commissioners has caused an assessment to be made against each lot or parcel or real property within the district based upon the cost of the improvements to be made and the benefits accruing to each lot and parcel of real property; and

WHEREAS, the Board of Commissioners has determined that real property within the district that does not adjoin North Caraway Road shall be assessed the amount of \$300 per parcel and that real property within the district which adjoins North Caraway Road shall be assessed the amount of \$6.83 per frontal footage; and

WHEREAS, the following owners of real property within the district have either paid in full their proposed assessments to the Board of Commissioners or they have committed to paying their assessments in one lump sum payment:
