RESOLUTION TO ENTER INTO AN AGREEMENT WITH JACK BRAND CONSTRUCTION CO. TO RESOLVE PROBLEMS CREATED BY PREVIOUS WORK PERFORMED WHEREAS, THE CITY OF JONESBORO PREVIOUSLY PAID JACK BRAND CONSTRUCTION CO., FOR WORK TO BE PERFORMED ON A DITCH MAINTENANCE PROJECT;

WHEREAS, A PROBLEM HAS BEEN IDENTIFIED WITH SOME OF THE WORK PERFORMED ON SAID DITCHES; AND

WHEREAS, THE CITY OF JONESBORO DESIRES TO RESOLVE PROBLEMS CREATED THEREBY;

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL FOR THE CITY OF JONESBORO, ARKANSAS THAT:

- 1. THE CITY COUNCIL HEREBY AGREES TO THE TERMS AND CONDITIONS OF AN AGREEMENT BETWEEN THE CITY OF JONESBORO AND JACK BRAND CONSTRUCTION AS FOLLOWS:
 - A) THE SUM OF \$20.000.00 WILL BE PAID BY JACK BRAND CONSTRUCTION TO THE CITY OF JONESBORO WITHIN 90 DAYS OF THIS RESOLUTION.
 - B) THAT A BILL PREVIOUSLY TENDERED FOR WORK PERFORMED IN THE AMOUNT OF \$7,000.00 SHALL BE CHARGED OFF BY JACK BRAND CONSTRUCTION AND NO PAYMENT MADE BY THE CITY OF JONESBORO.
 - C) THAT IN ADDITION THERETO A LIST OF REPAIRS SHALL BE PERFORMED BY JACK BRAND CONSTRUCTION ACCORDING TO THE TERMS OF AN AGREEMENT ATTACHED HERETO AS EXHIBIT "A".
- THAT THE MAYOR AND CITY CLERK ARE AUTHORIZED TO EXECUTE SUCH DOCUMENTS
