BERNARDS HEALTHCARE

WHEREAS, the property owners have filed a petition with the City Clerk of the City Jonesboro, Arkansas requesting that Jackson Street between Church Street and Carson Street be closed AND a 15' alley as described as follows:

DESCRIPTION

A 15 FOOT ALLEY LYING BETWEEN LOT 15 AND LOT 18 OF NASH'S ADDITION TO THE CITY OF JONESBORO, ARKANSAS, LOTS 18 THROUGH 27, LOT 36 AND LOT 37 OF COBB'S SURVEY OF THE SW1/4, SE1/4 OF SECTION 18. TOWNSHIP 14 NORTH, RANGE 4 EAST. AND LOT 1 OF THE MID-SOUTH BANK FIRST REP LAT. CONTAINING SOME 11.851 SQ. FT. OR 0.272 ACRES, MORE OR LESS. SUBJECT TO EASEMENTS, RESTRICTIONS, RESERVATIONS AND RIGHTS-OF-WAY OF RECORD.

Be vacated and abandoned; and

WHEREAS, the Petition has been presented to the City Council of the City of Jonesboro, Arkansas; AND

WHEREAS, Arkansas Code Annotated 14-301-110 requires two weeks public notice before the above

easement can be vacated and abandoned;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Jonesboro, Arkansas that the City Clerk is directed to publish a notice once a week for two consecutive weeks advising the public of the request by the property owners to vacate and abandon Jackson A venue between Church Street and Carson Street and the alley mentioned above and this matter will be heard before the City Council on February 6, 2018 at 5:20 p.m. in the Council Chambers, 300 South Church, Jonesboro, Arkansas.
