A RESOLUTION TO THE CITY COUNCIL OF JONESBORO, ARKANSAS AUTHORIZING THE OFFER AND ACCEPTANCE TO PURCHASE ADDITIONAL RIGHT-OF-WAY AT 804 CREATH AVENUE FOR THE PURPOSE OF THE CONSTRUCTING AND MAINTAINING ROADWAY IMPROVEMENTS WHEREAS, the City of Jonesboro, Arkansas desires to purchase the following described right-of-way for the purpose of constructing and maintaining roadway improvements:

PART OF LOT 11, BLOCK 2 OF MATTHEWS ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTHWEST CORNER OF LOT 11, BLOCK 2 OF MATTHEWS ADDITION, JONESBORO, CRAIGHEAD COUNTY, ARKANSAS; THENCE NORTH 00°23'38" WEST, ALONG THE WEST LINE OF SAID LOT 11, 10.61 FEET; THENCE NORTH 89°13'05" EAST, LEAVING SAID WEST LINE, 6.25 FEET; THENCE SOUTH 00°32'30" EAST, 7.04 FEET; THENCE NORTH 89°27'16" EAST, 63.74 FEET; THENCE SOUTH 00°27'27" EAST, 3.63 FEET TO THE SOUTH LINE OF SAID LOT 11; THENCE SOUTH 89°28'35" WEST, ALONG SAID SOUTH LINE, 70.00 FEET TO THE POINT OF BEGINNING, CONTAINING 297 SQ.
