U.S. Geological Survey, United States Department of the Interior contract for installation, operation and maintenance of two streamgauges

U.S. Geological Survey, United States Department of the Interior was awarded the contract for the installation, operation and maintenance of two streamgauges and was signed on September 1, 2009. The contract amount is for \$10,270 for 2009 and \$25,000 for 2010 and the length of the contract is from September 1, 2009, to December 31, 2010. The resolution number is RES-09:126 and was approved by the City Council on August 31, 2009.

The contract was extended to include 2010 for two streamgagues located at Whiteman’s Creek at Industrial Drive and the other one located at Lost Creek at Floyd Street and was signed December 21, 2009. The contract amount is for \$25,000 and the length of the contract is from January 1, 2010, to December 31, 2010.

The contract was extended a second time to include 2011 for the two streamgauges and was signed on December 30, 2010. The contract amount is for \$25,000 and the length of the contract is from January 1, 2011, to December 31, 2011.

The contract was extended a third time to include 2012 for the two streamgauges and was signed on December 21, 2011. The contract amount is for \$27,000 and the length of the contract is from January 1, 2012, to December 31, 2012. The resolution number is RES-11:206 and was approved by Council on December 20, 2011.

The contract was extended a fourth time to include the two streamgauges for 2013 and was signed on January 23, 2013. The contract amount is for \$27,000 and the length of the contract is from January 1, 2013, to December 31, 2013. The resolution number is RES-12:218 and was approved by Council on January 22, 2013.

The contract was extended a fifth time to include two streamgauges for 2014. The contract amount is for

\$27,300 and the length of the contract is from January 1, 2014, to December 31, 2014. The resolution number is RES-13:203 and was approved by Council on December 17, 2013.

The contract was extended a sixth time to include two streamgages for 2015. The contract amount is for \$27,300 and the length of the contract is from January 1, 2015, to December 31, 2015. The resolution number is RES-14:224 and was approved by the City Council on January 20, 2015.

The contract was extended a seventh time to include two streamgages for 2016. The contract amount is for \$28,300 and the length of the contract is from January 1, 2016, to December 31, 2016. The resolution is RES-15:165 and was approved by the City Council on December 15, 2015.
