Arkansas State Highway Transportation Department's (AHTD) Safe Routes to School Program Arkansas State Highway Transportation Department (AHTD) entered into an Agreement of Understanding with the City of Jonesboro for the Safe Routes to School Program for the development of the Turtle Creek Greenway and was signed on November 28, 2007. The contract amount is for \$250,000. The resolution number is RES-07:2542 and was approved by the City Council on November 20, 2007.

They also entered into a contract for the 2007 Safe Routes to School Grant with the City for the construction of the Turtle Creek Greenway, Job No. 100666. The contract amount is for \$287,500 and the work is to be completed by May 31, 2009. The resolution number is RES-08:084 and was approved by the City Council on May 20, 2008.

They also entered into an Agreement of Understanding for the Safe Routes to School Grant with the City for Job No. 100681. The contract amount is 100% funded using Federal Funds. The resolution number is RES-08:180 and was approved by the City Council on November 6, 2008.

They also entered into a Agreement of Understanding for the Safe Routes to School Grant with the City for Job No. 100734. The contract amount for this project is \$81,917, which is 100% federally funded. The resolution number is RES-10:101 and was approved by Council on September 21, 2010.

They also entered into a Agreement of Understanding for the Safe Routes to School Grant with the City for Job No. 100772 and was signed on March 6, 2012. The project will install two flashers at Westside School and construct sidewalks at University Heights, Philadelphia Elementary and Nettleton Junior High. The grant amount is for \$194,946. The resolution number is RES-12:031 and was approved by Council on March 6, 2012.
